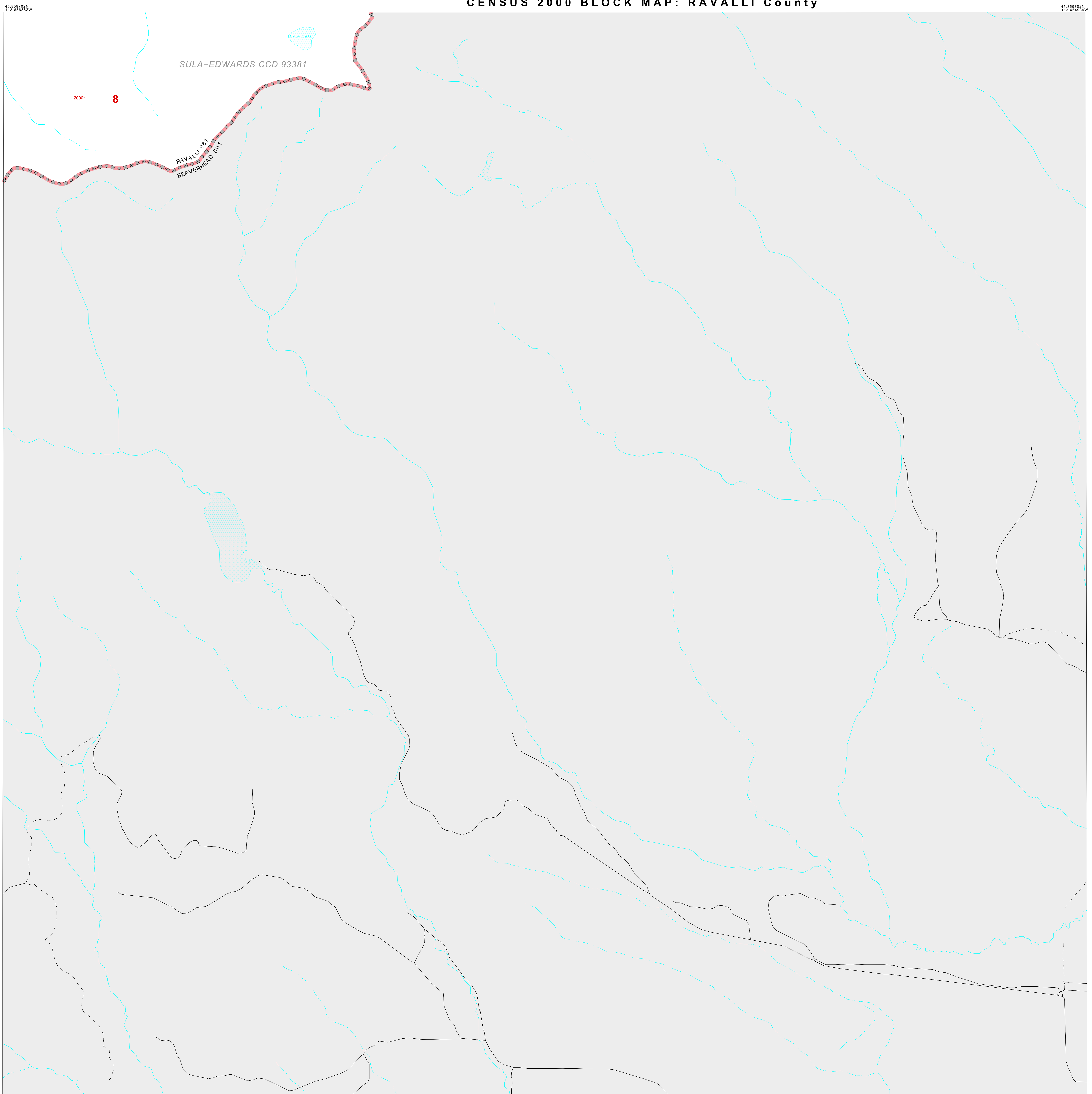


CENSUS 2000 BLOCK MAP: RAVALLI County
