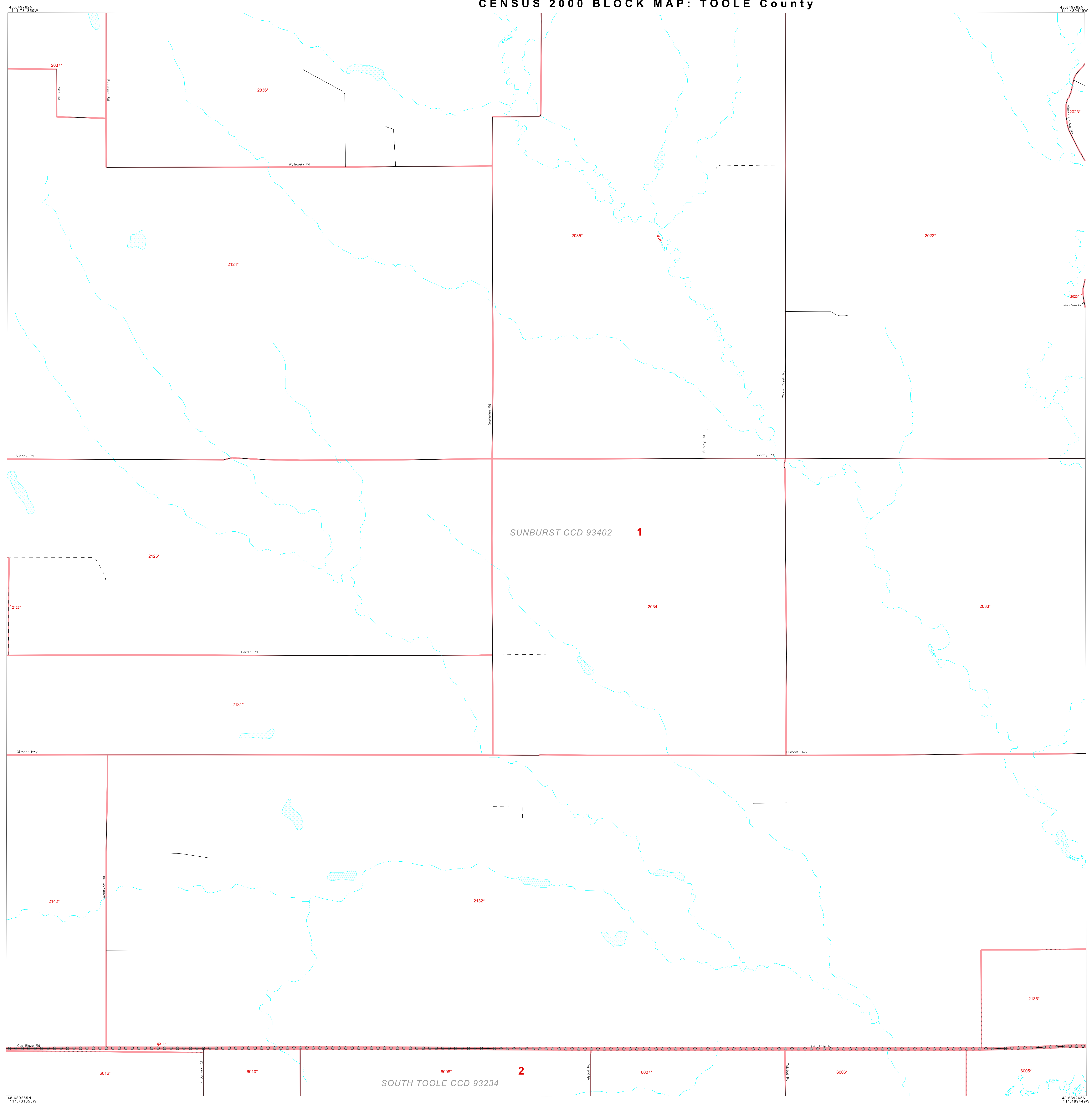


CENSUS 2000 BLOCK MAP: TOOLE County
