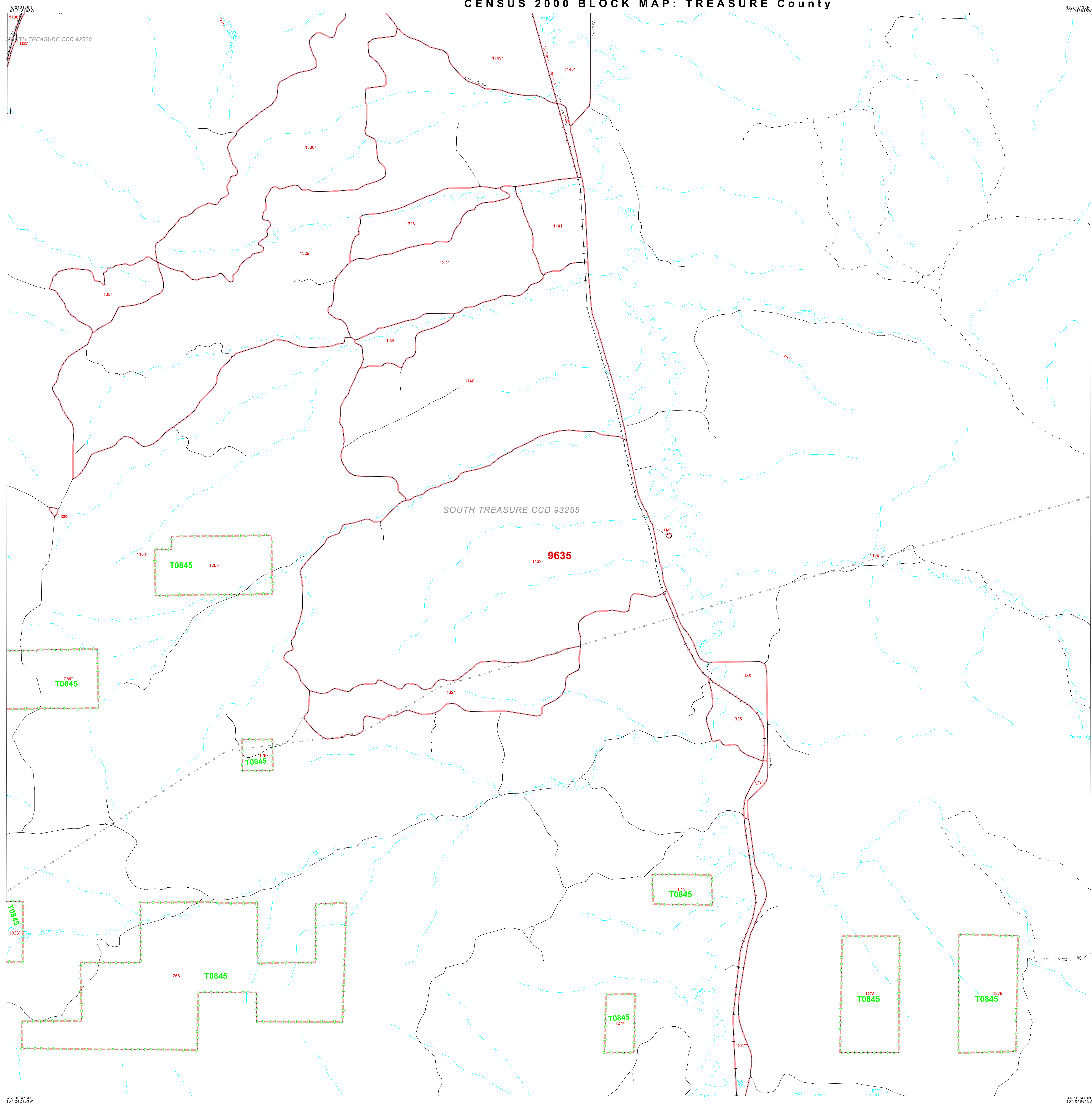


CENSUS 2000 BLOCK MAP: TREASURE County

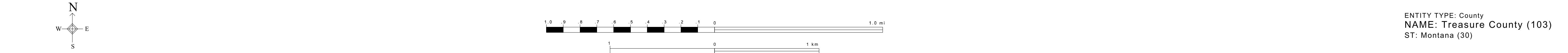
