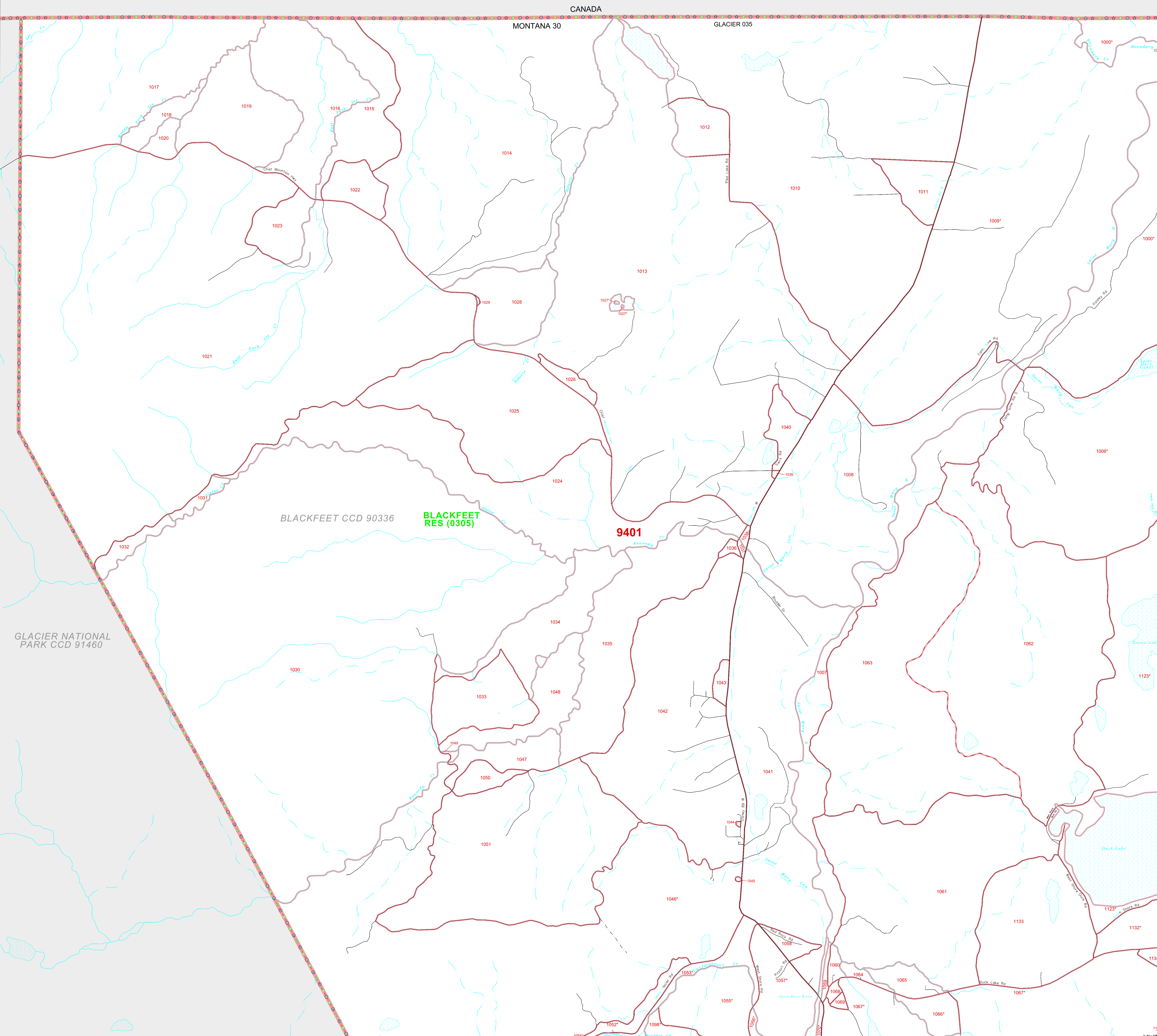


CENSUS 2000 BLOCK MAP: BLACKFEET CCD

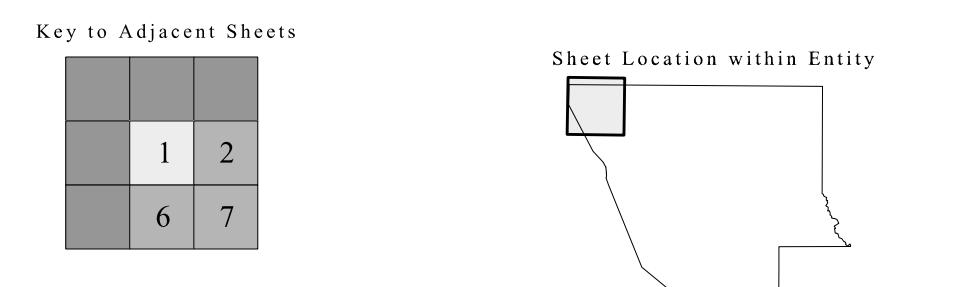
