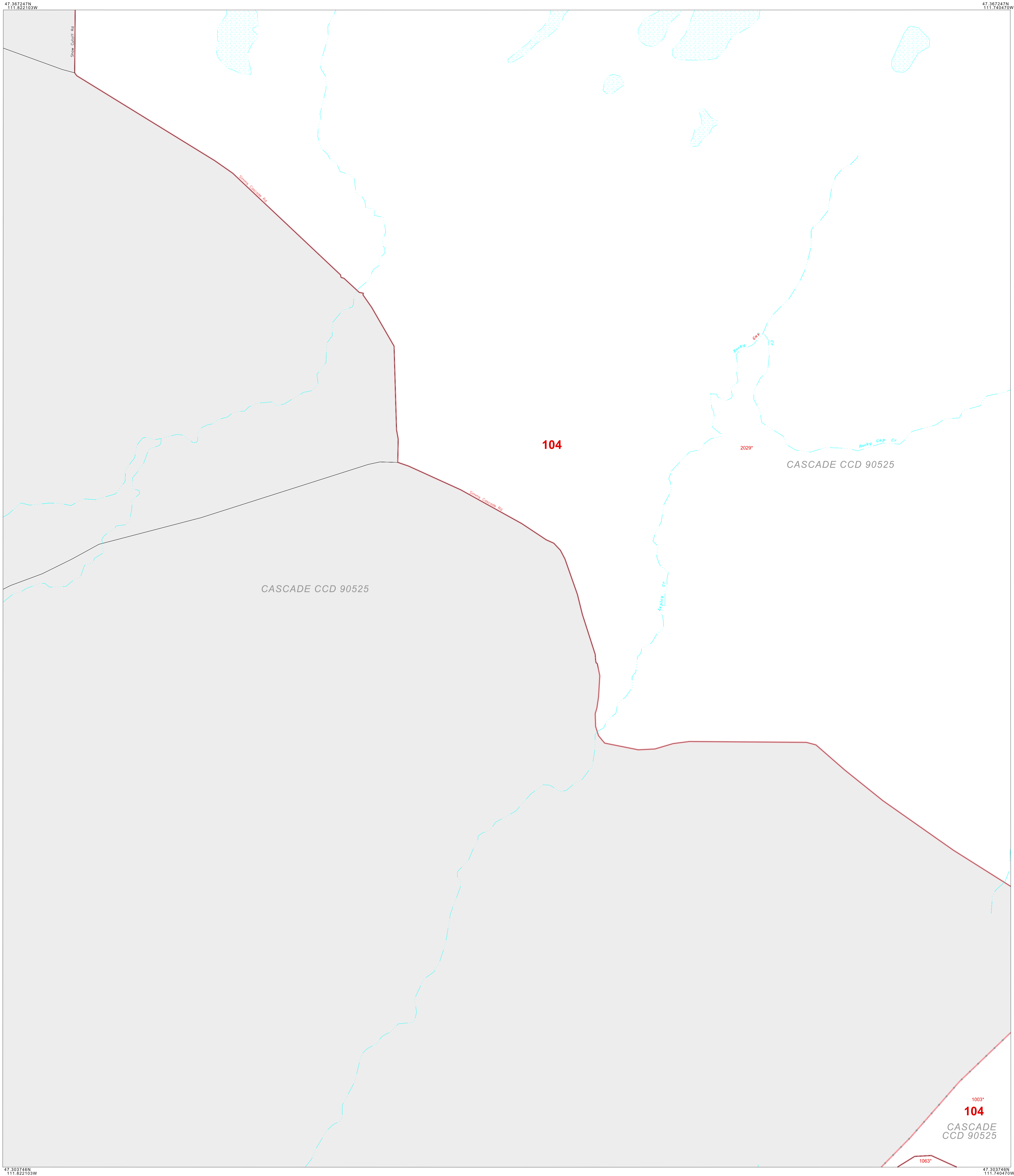


CENSUS 2000 BLOCK MAP: CASCADE CCD
