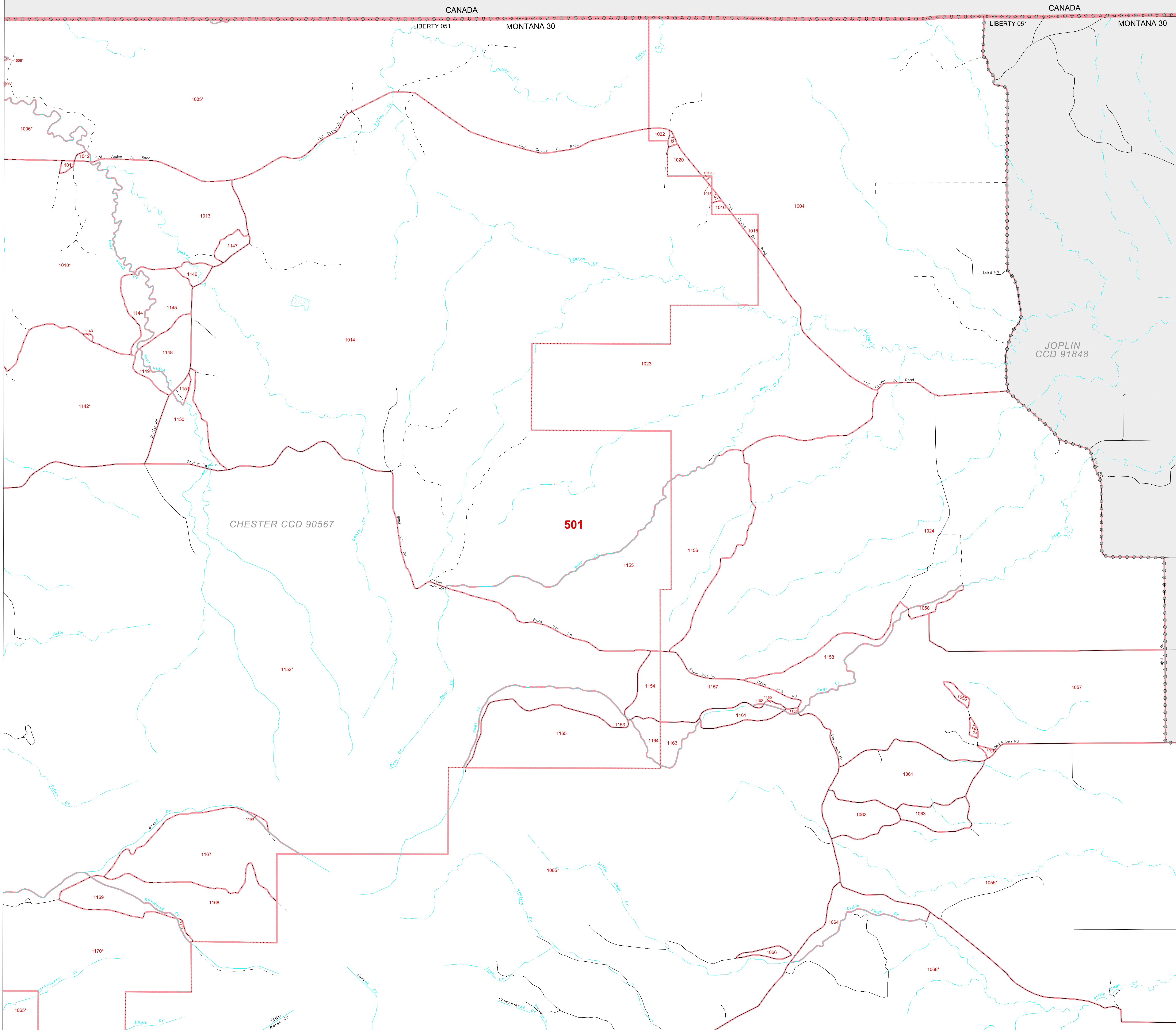


CENSUS 2000 BLOCK MAP: CHESTER CCD
