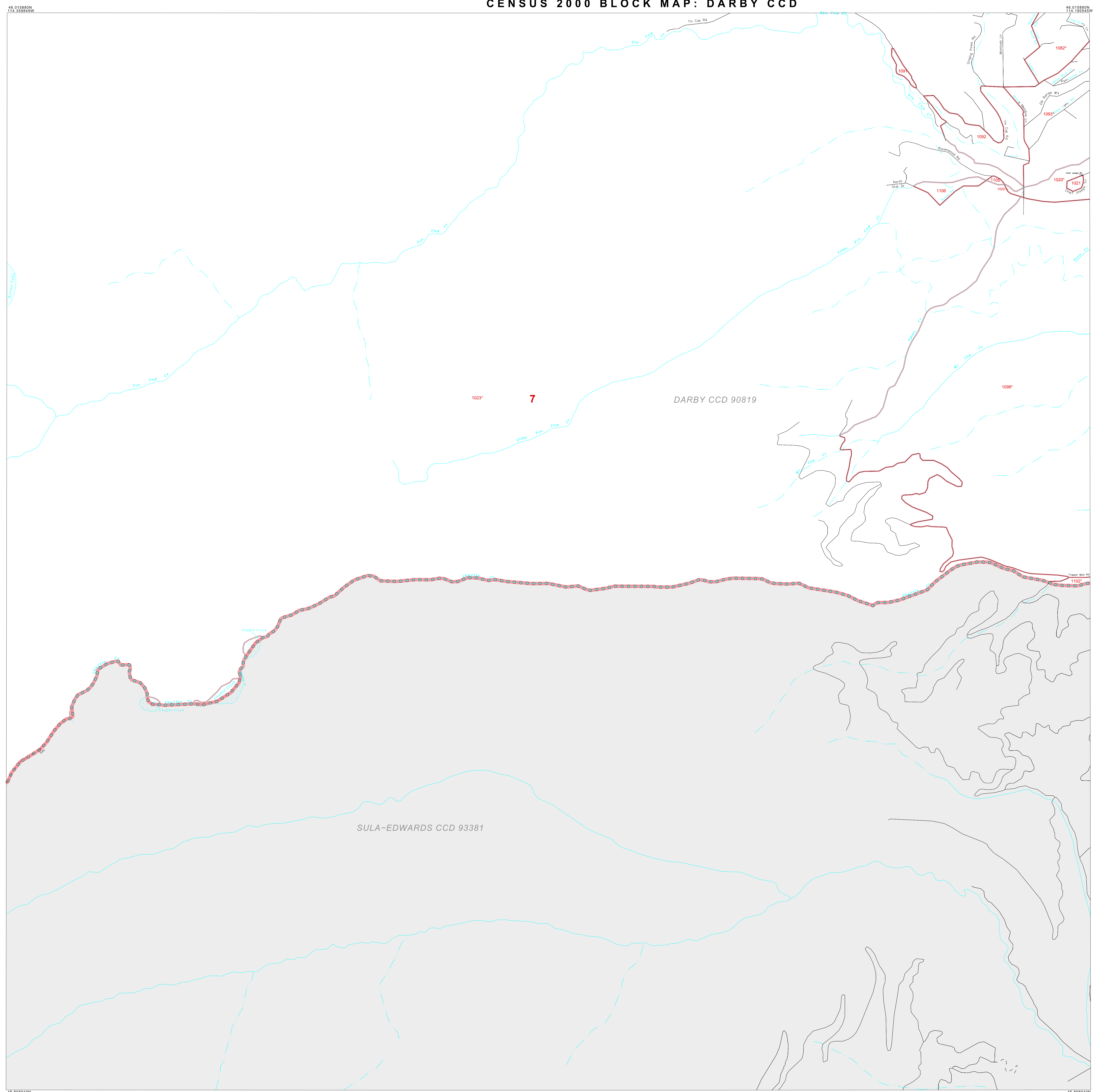


CENSUS 2000 BLOCKMAP: DARBY CCD
