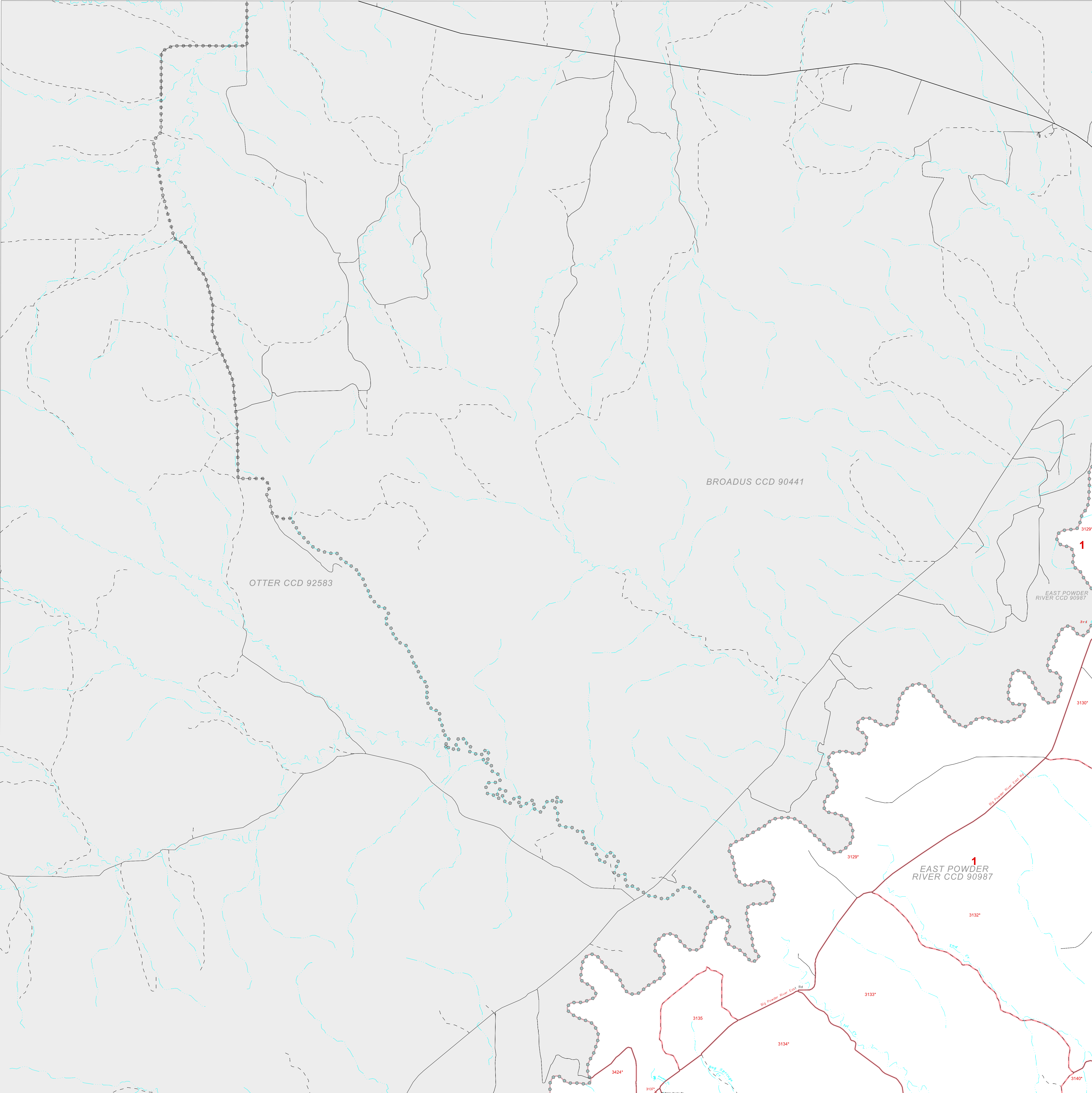


CENSUS 2000 BLOCK MAP: EAST POWDER RIVER CCD
