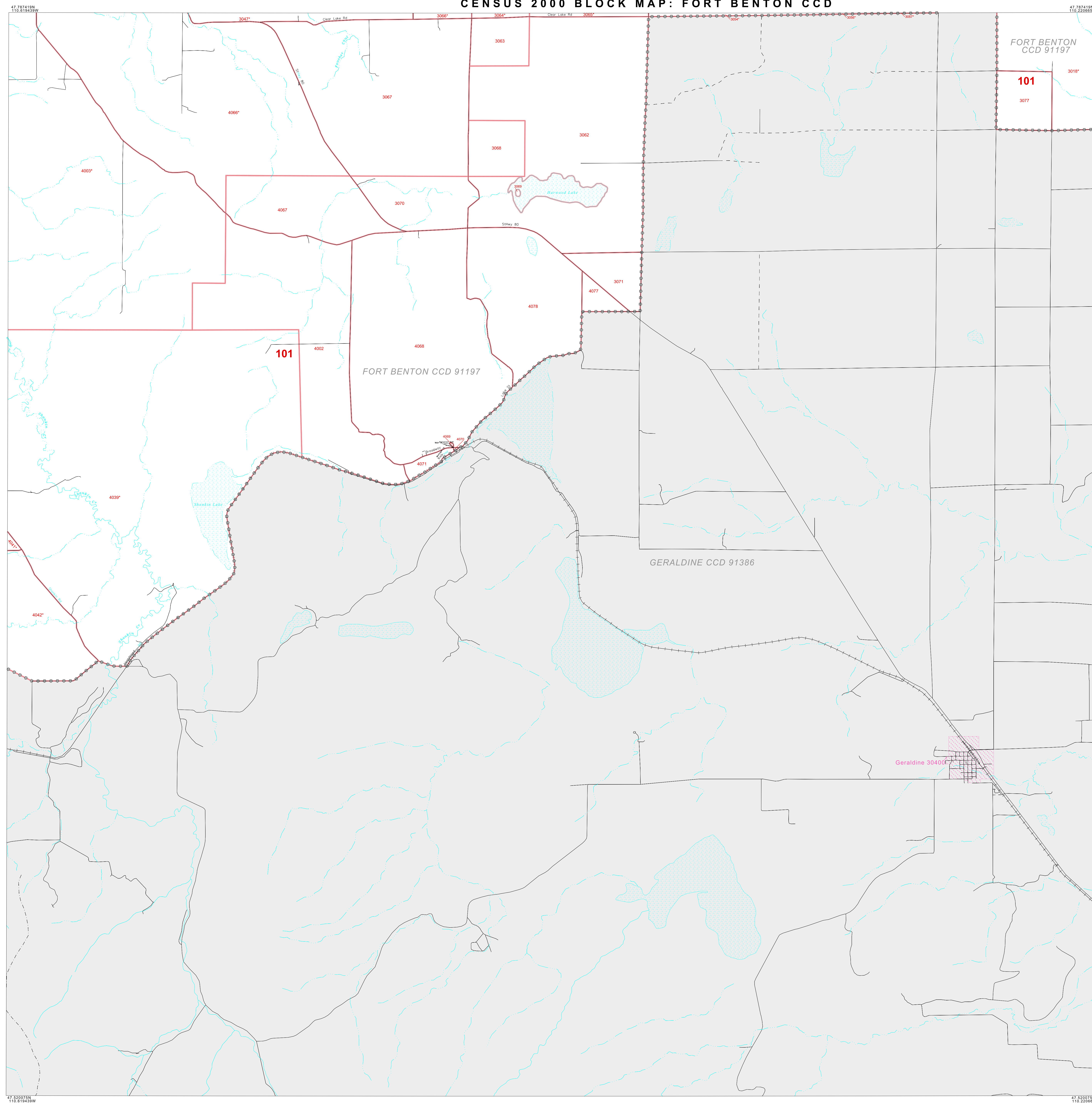


CENSUS 2000 BLOCK MAP: FORT BENTON CCD
