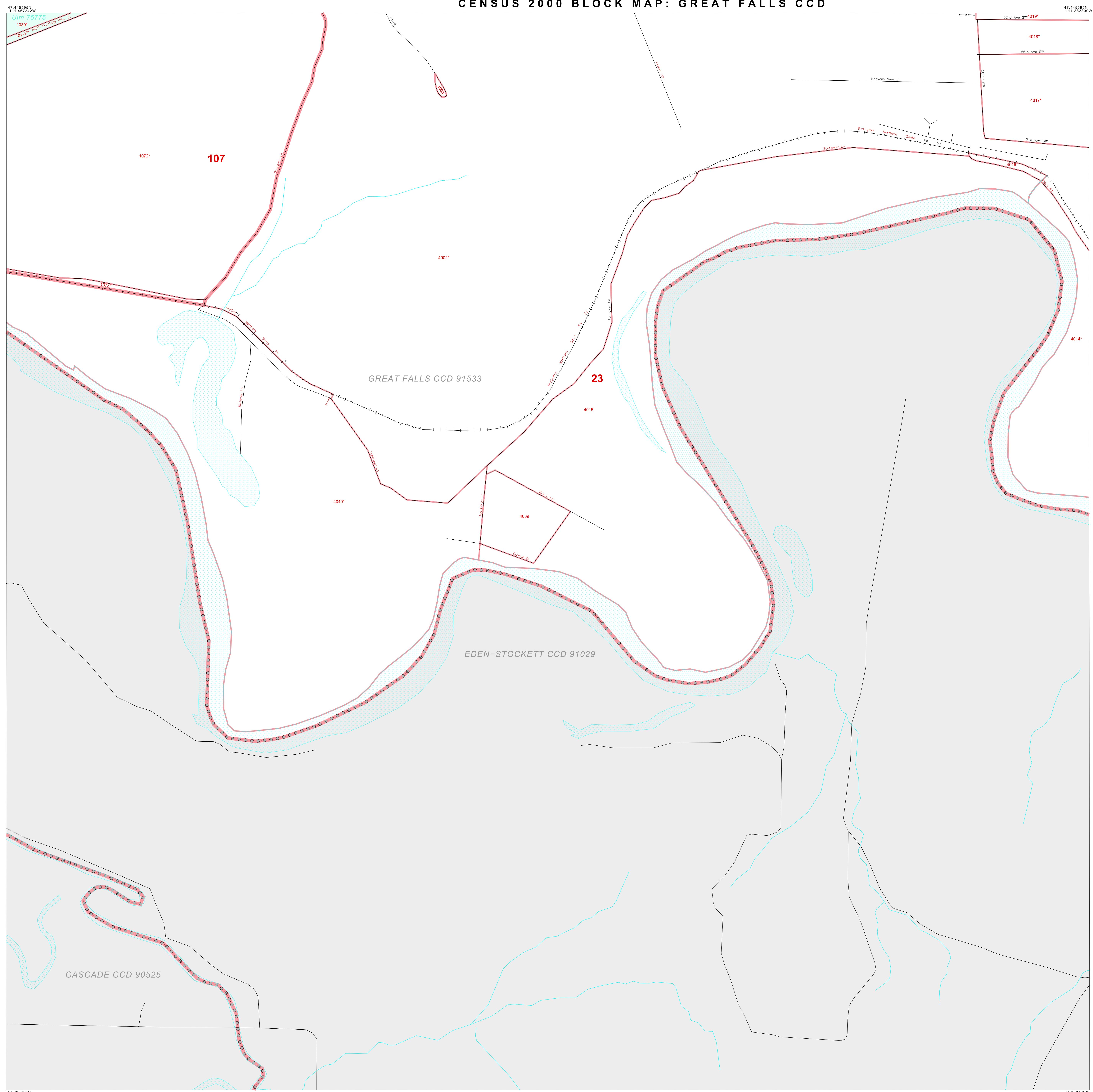


CENSUS 2000 BLOCK MAP: GREAT FALLS CCD
