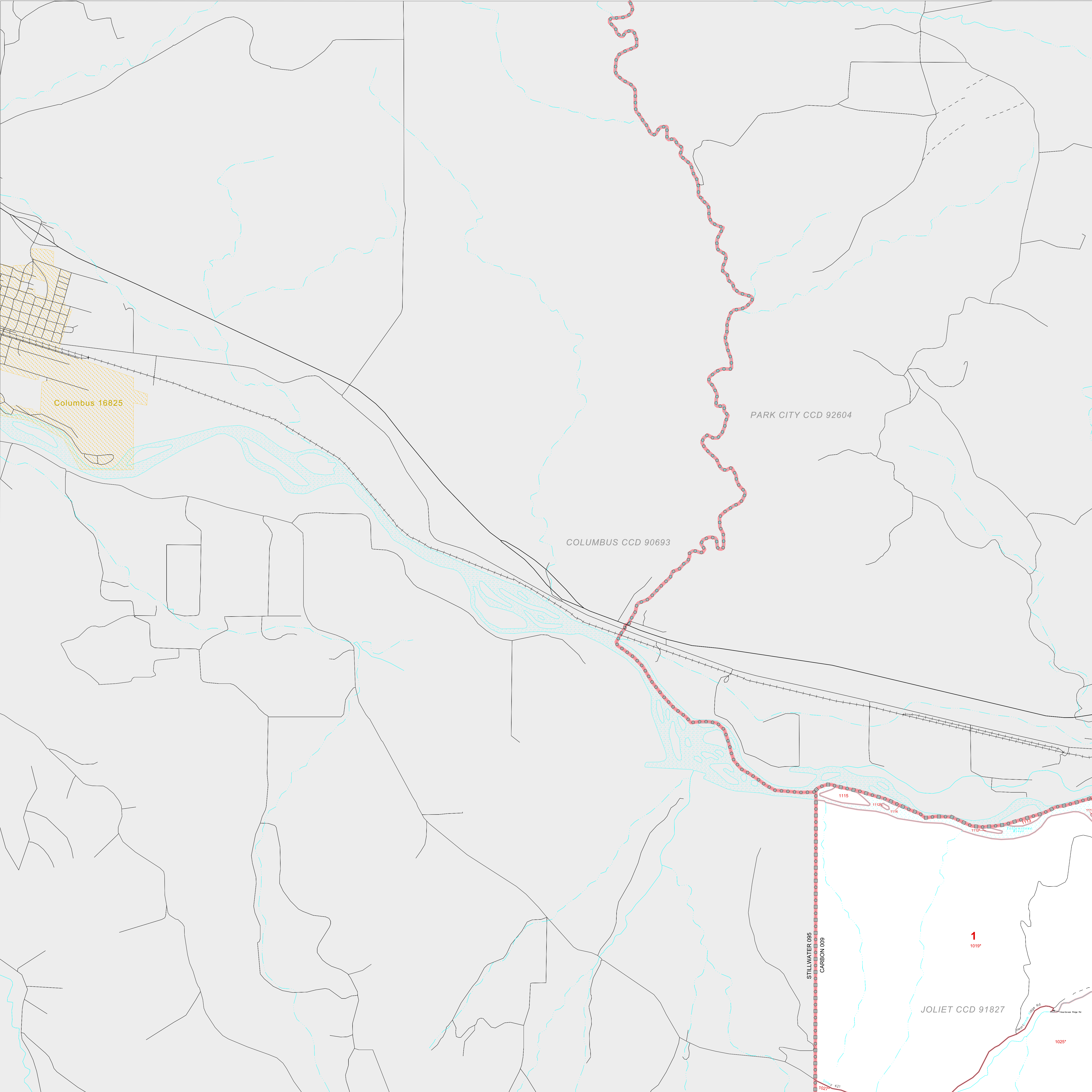


CENSUS 2000 BLOCKMAP: JOLIET CCD

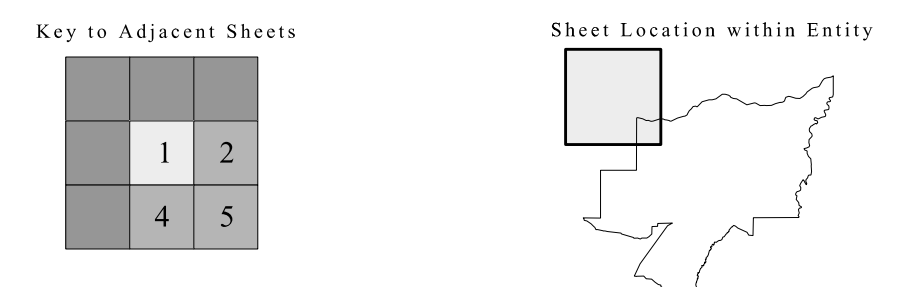
