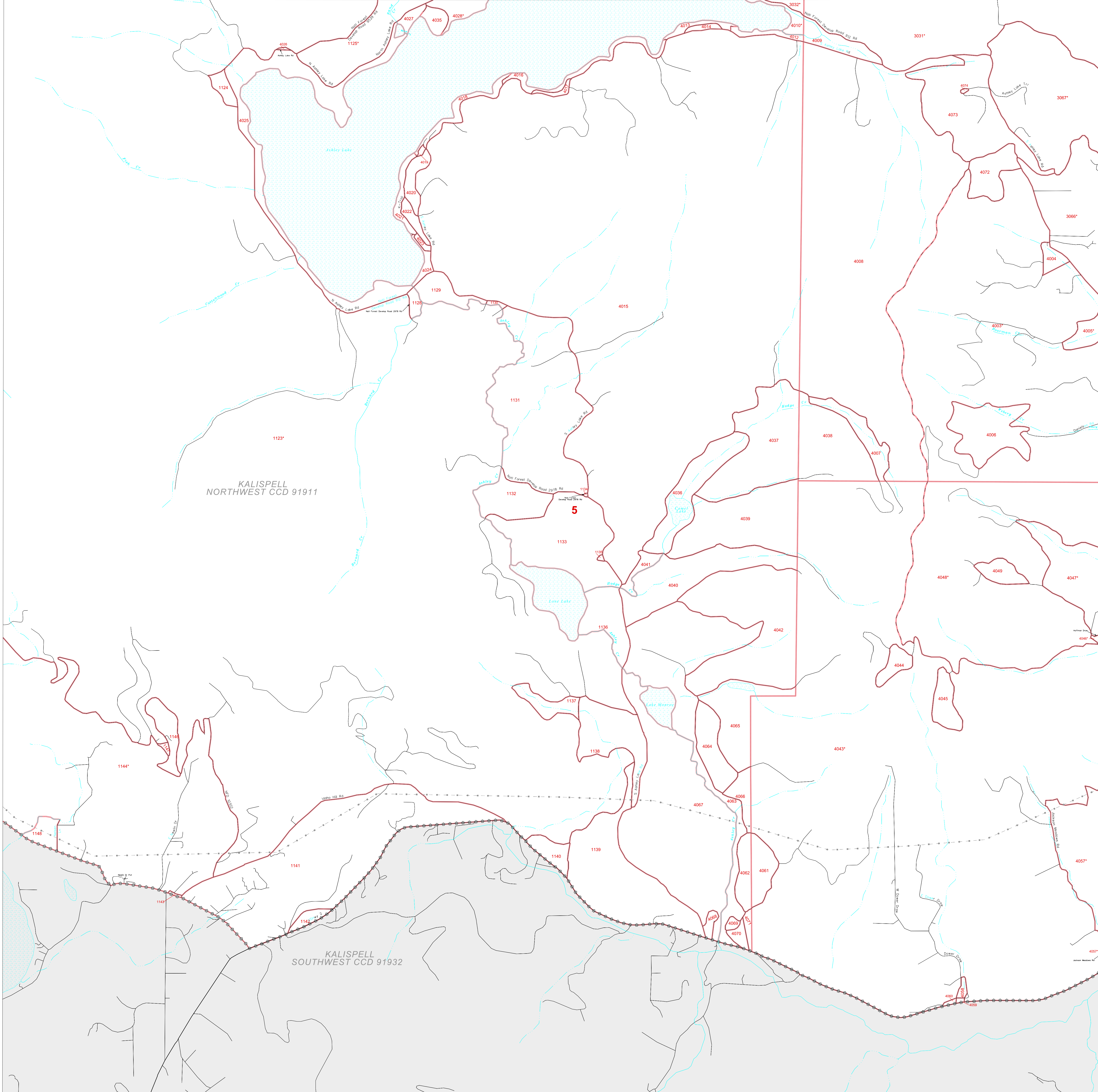


CENSUS 2000 BLOCK MAP: KALISPELL NORTHWEST CCD

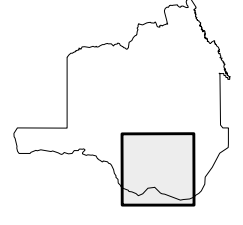

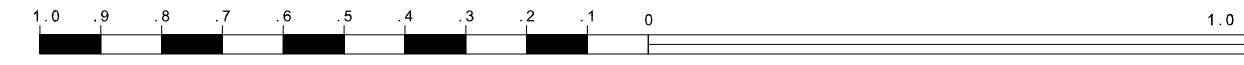
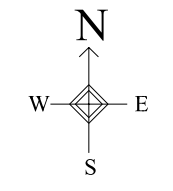
