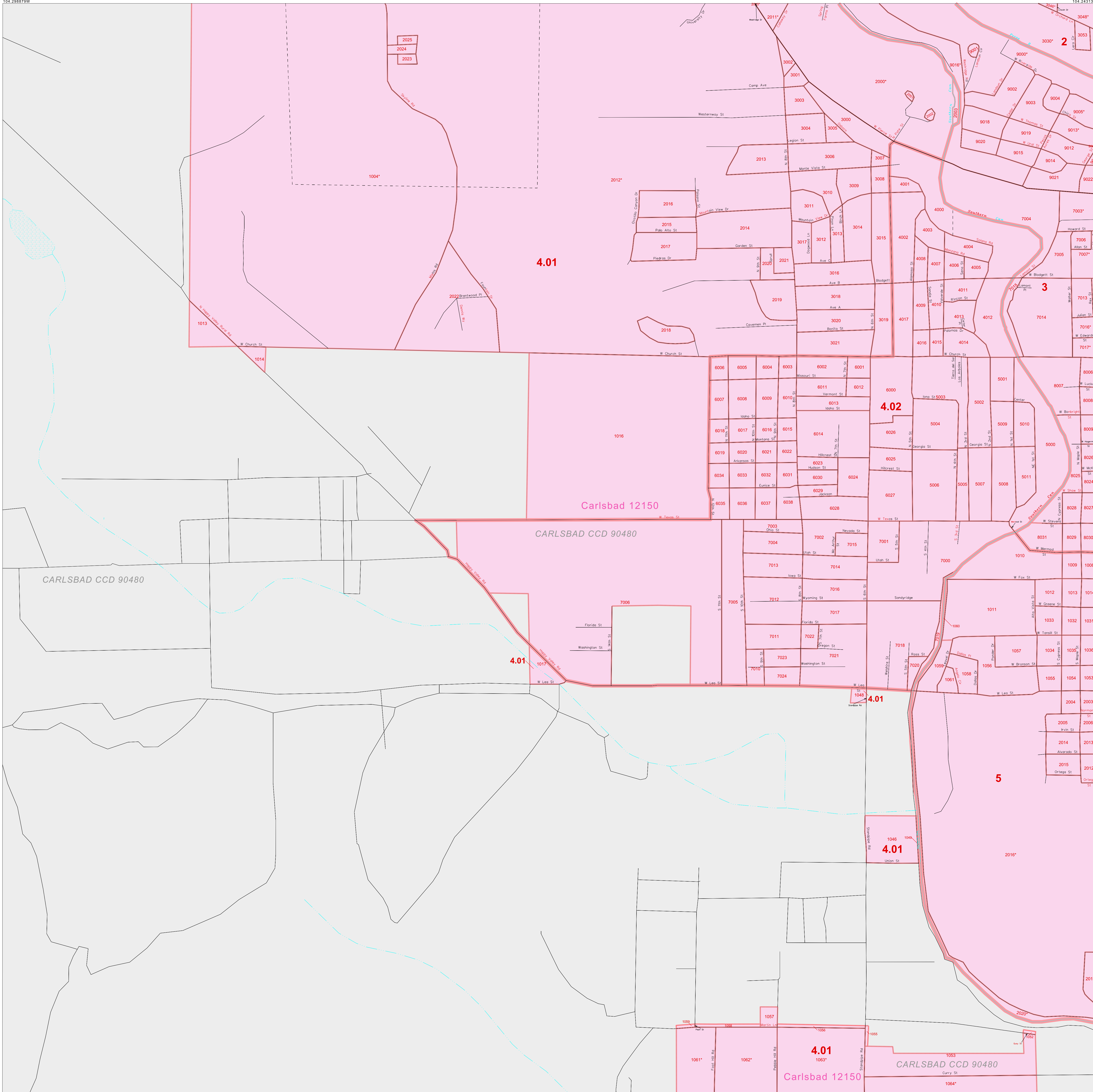


CENSUS 2000 BLOCK MAP: CARLSBAD City

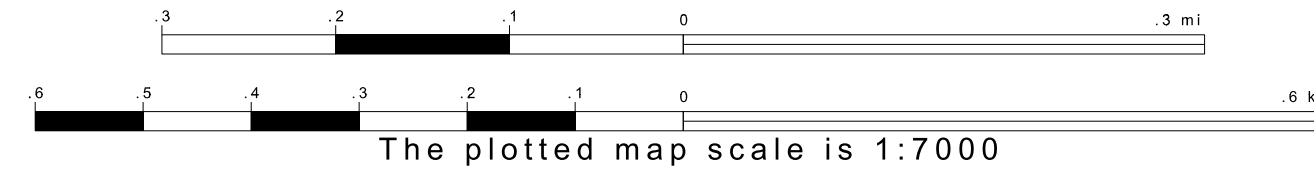
