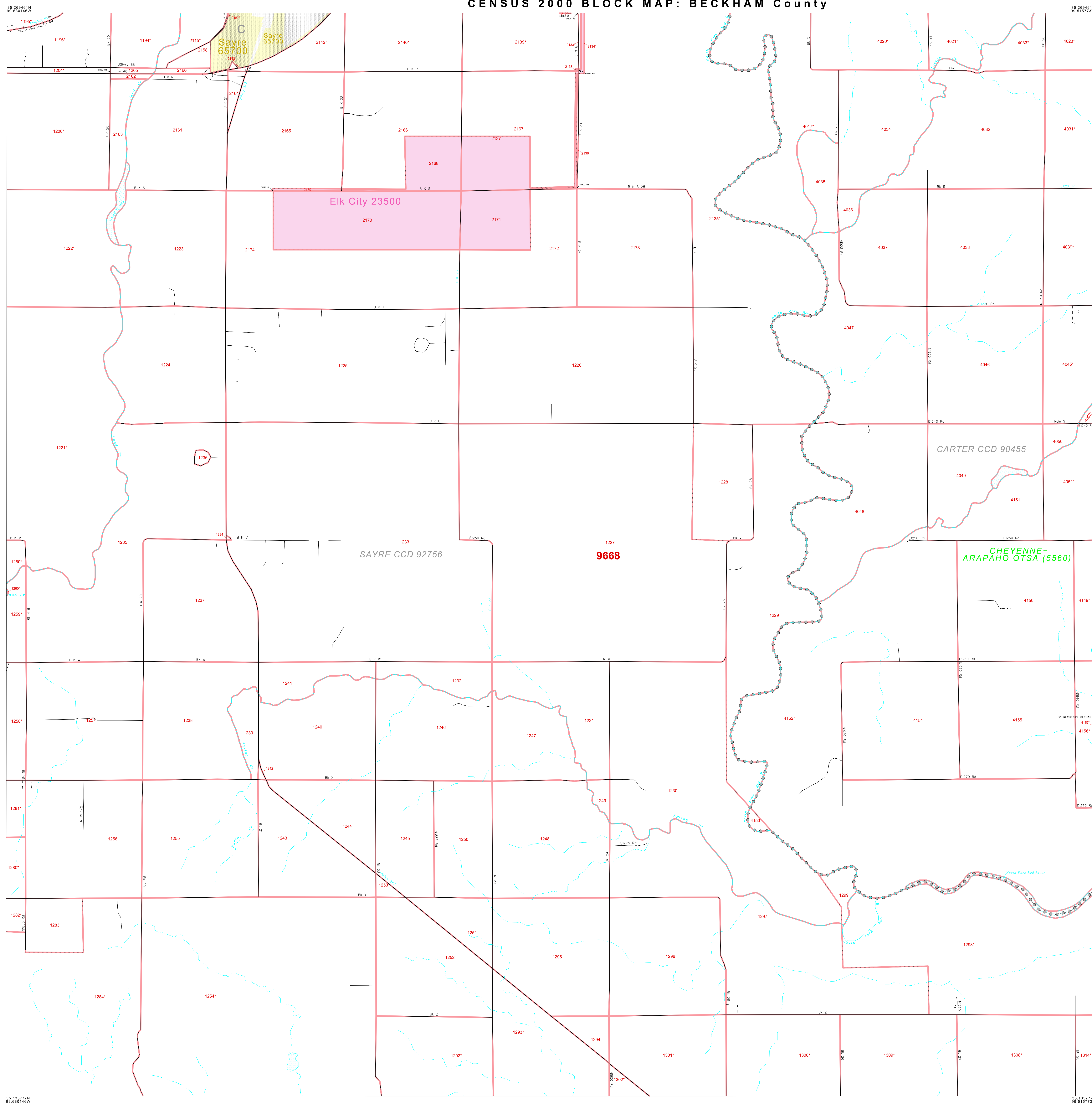


CENSUS 2000 BLOCK MAP: BECKHAM County

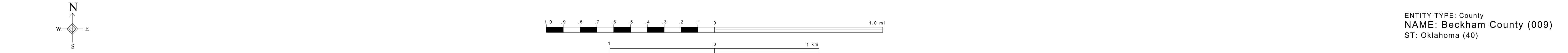
