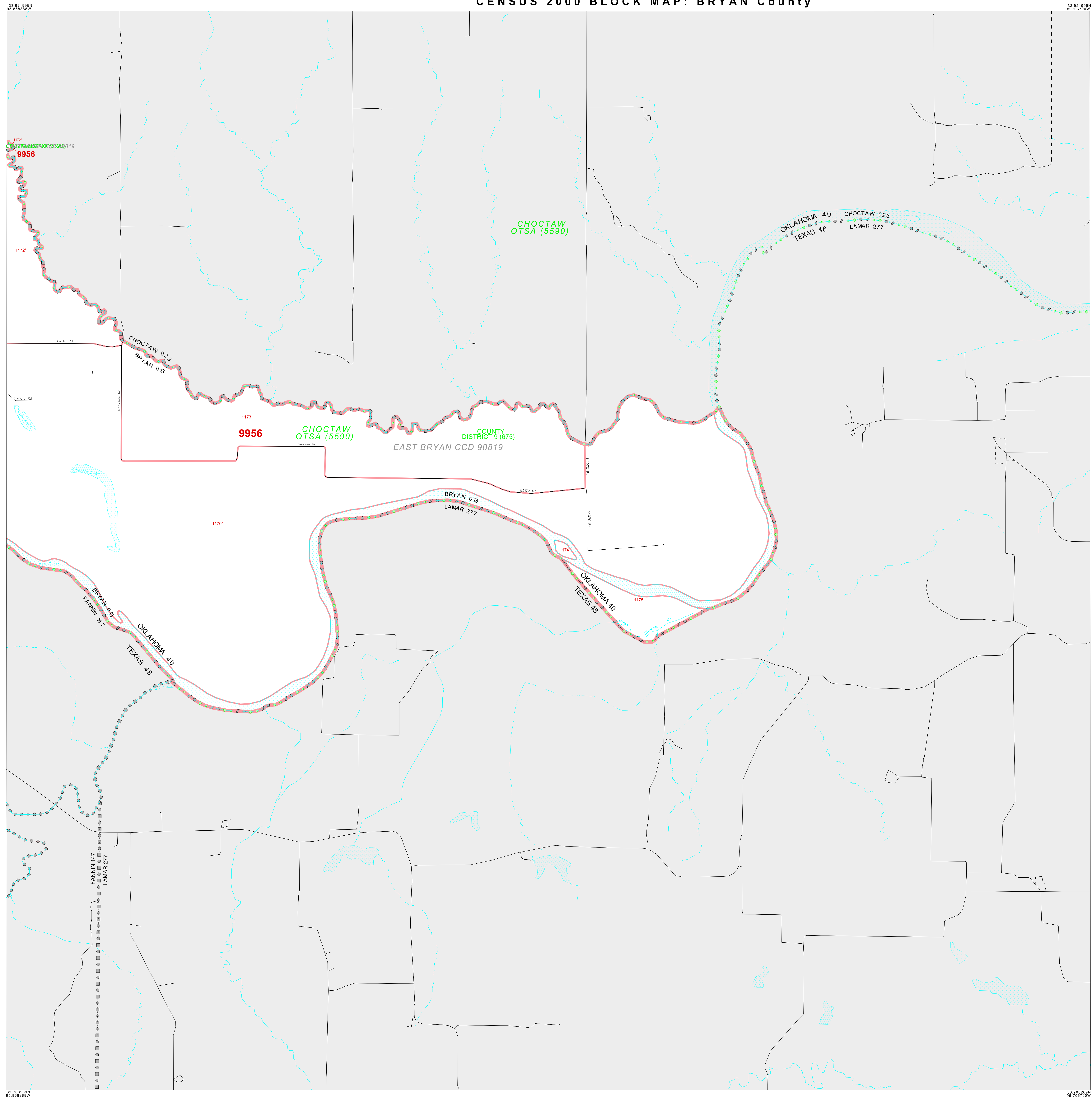


CENSUS 2000 BLOCK MAP: BRYAN County
