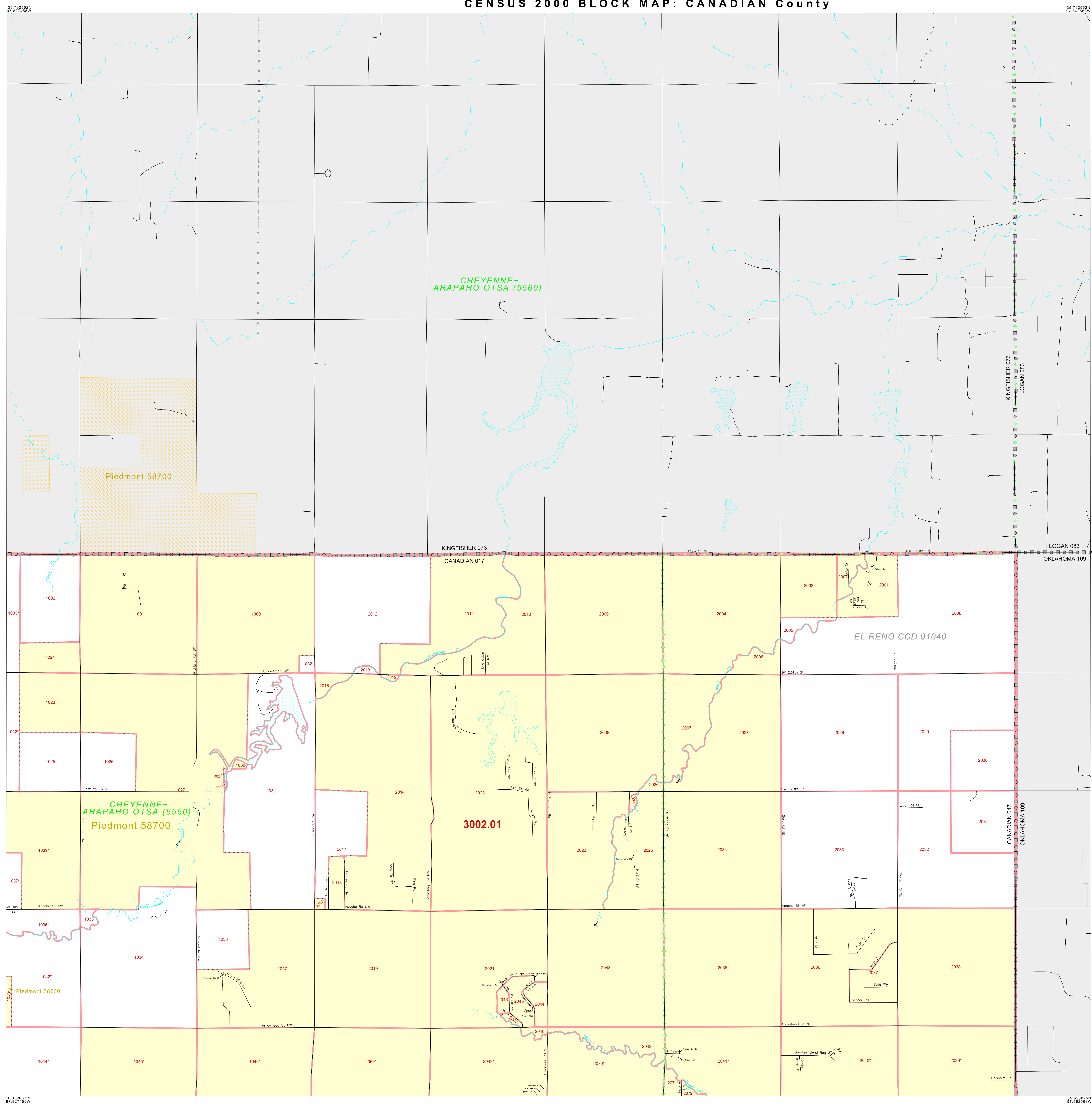


CENSUS 2000 BLOCK MAP: CANADIAN County

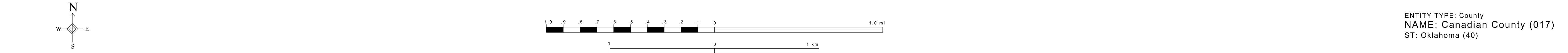
