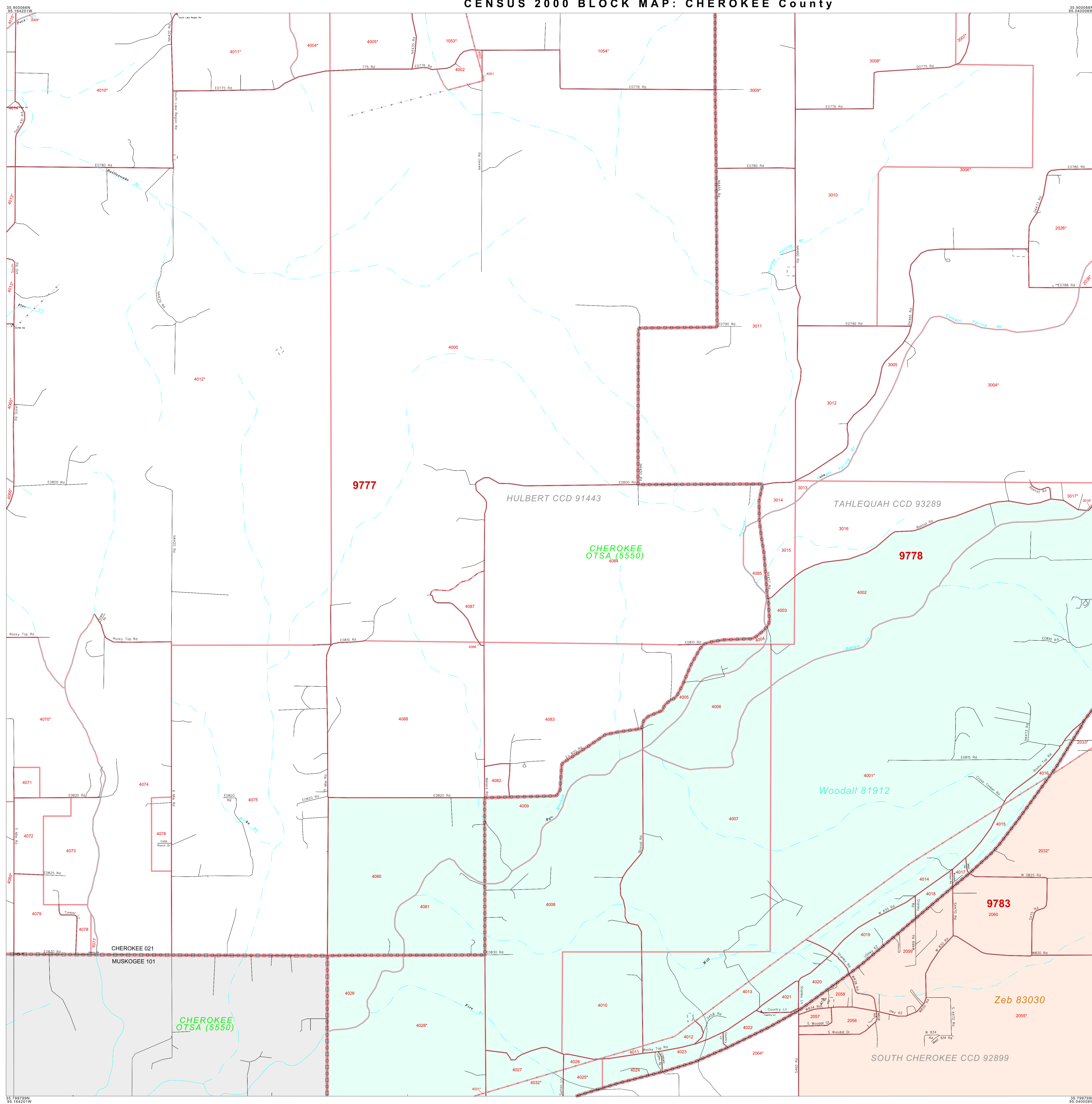


CENSUS 2000 BLOCK MAP: CHEROKEE County
