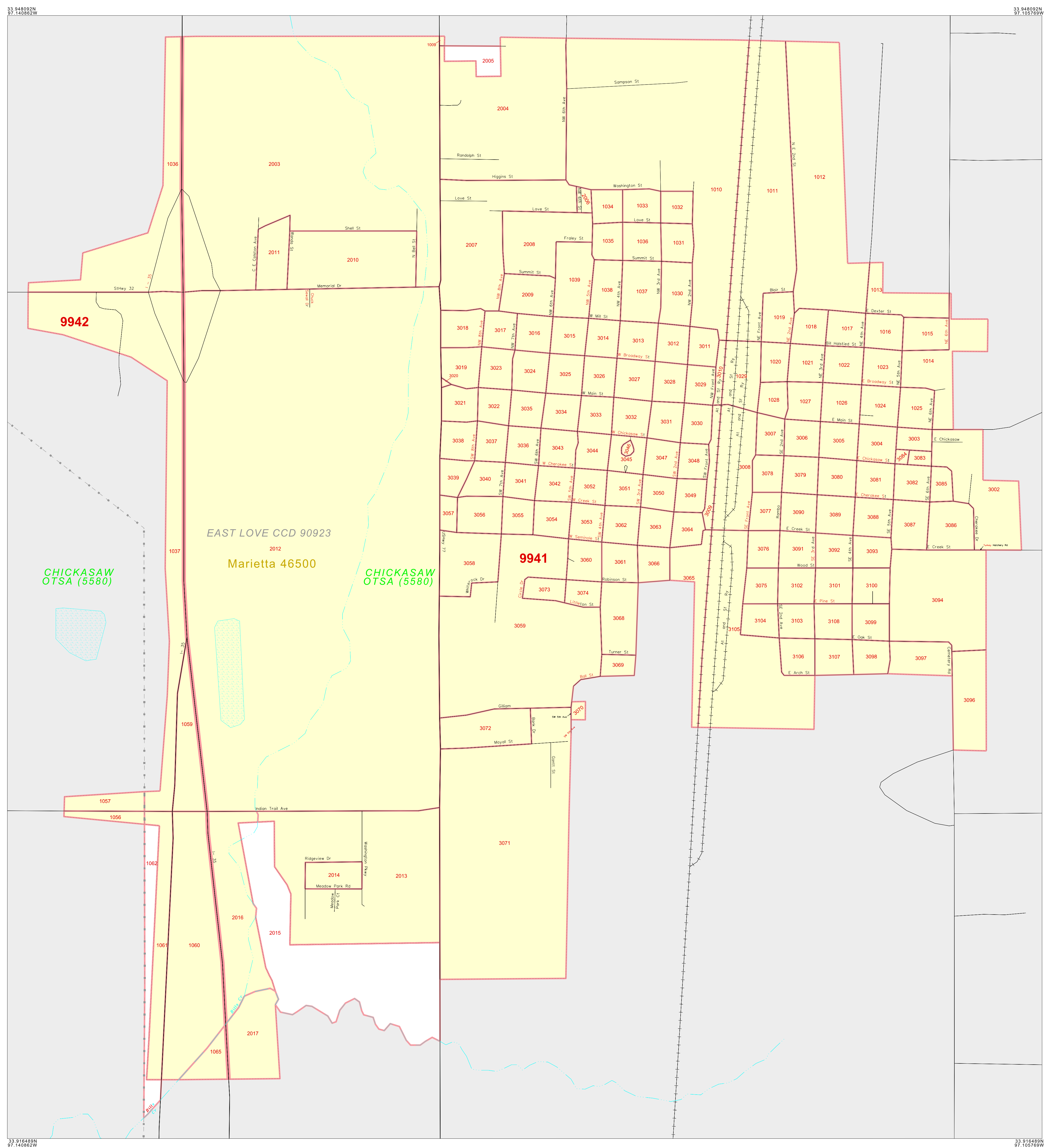


CENSUS 2000 BLOCK MAP: LOVE County
