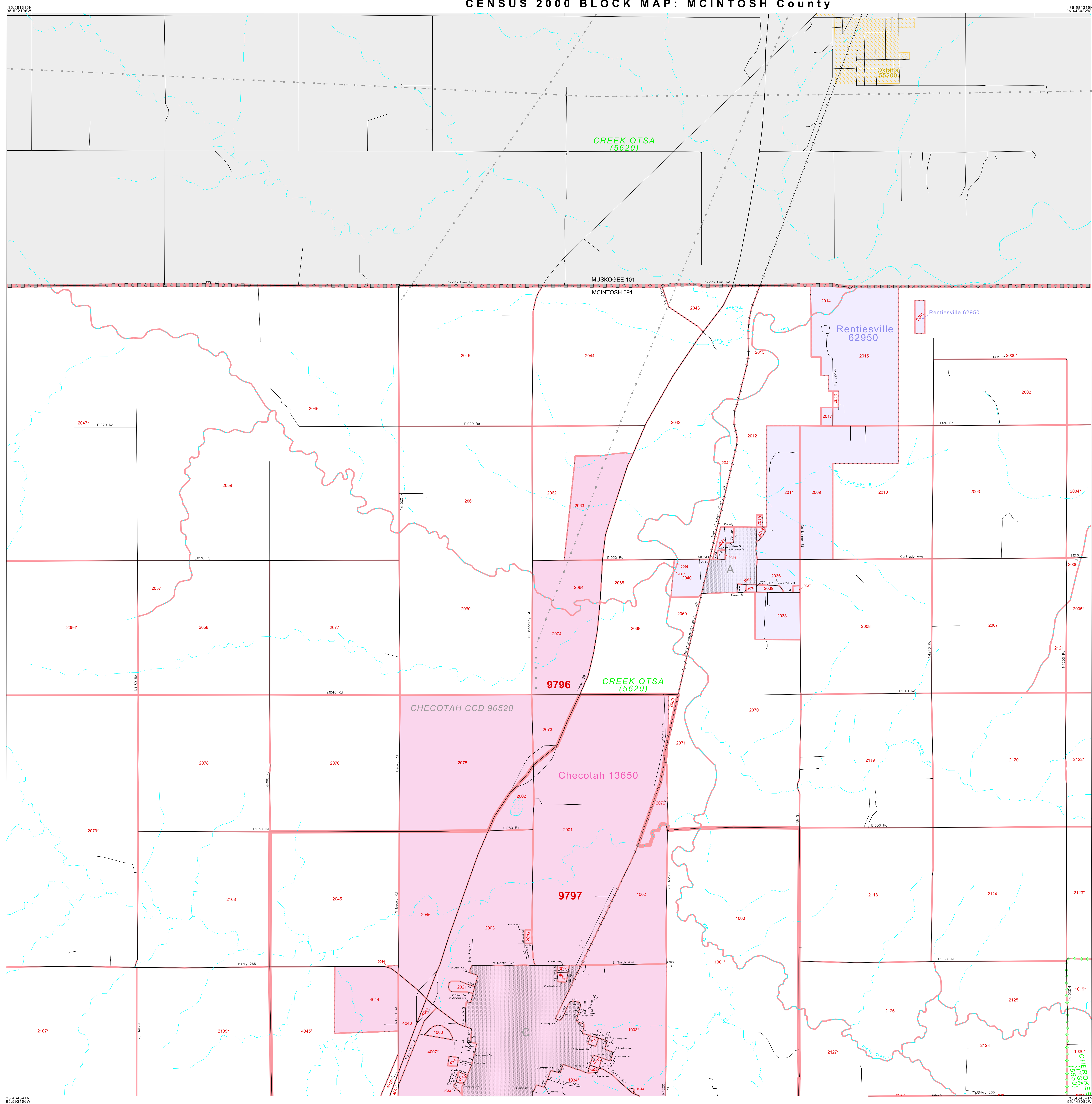


CENSUS 2000 BLOCK MAP: MCINTOSH County

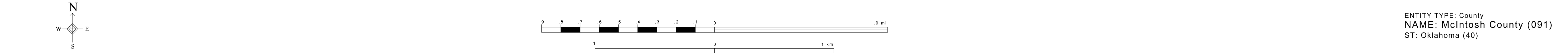

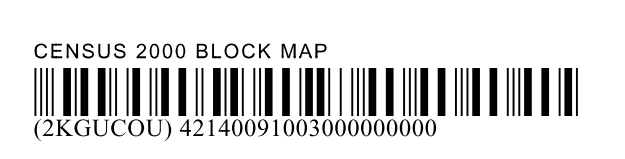
