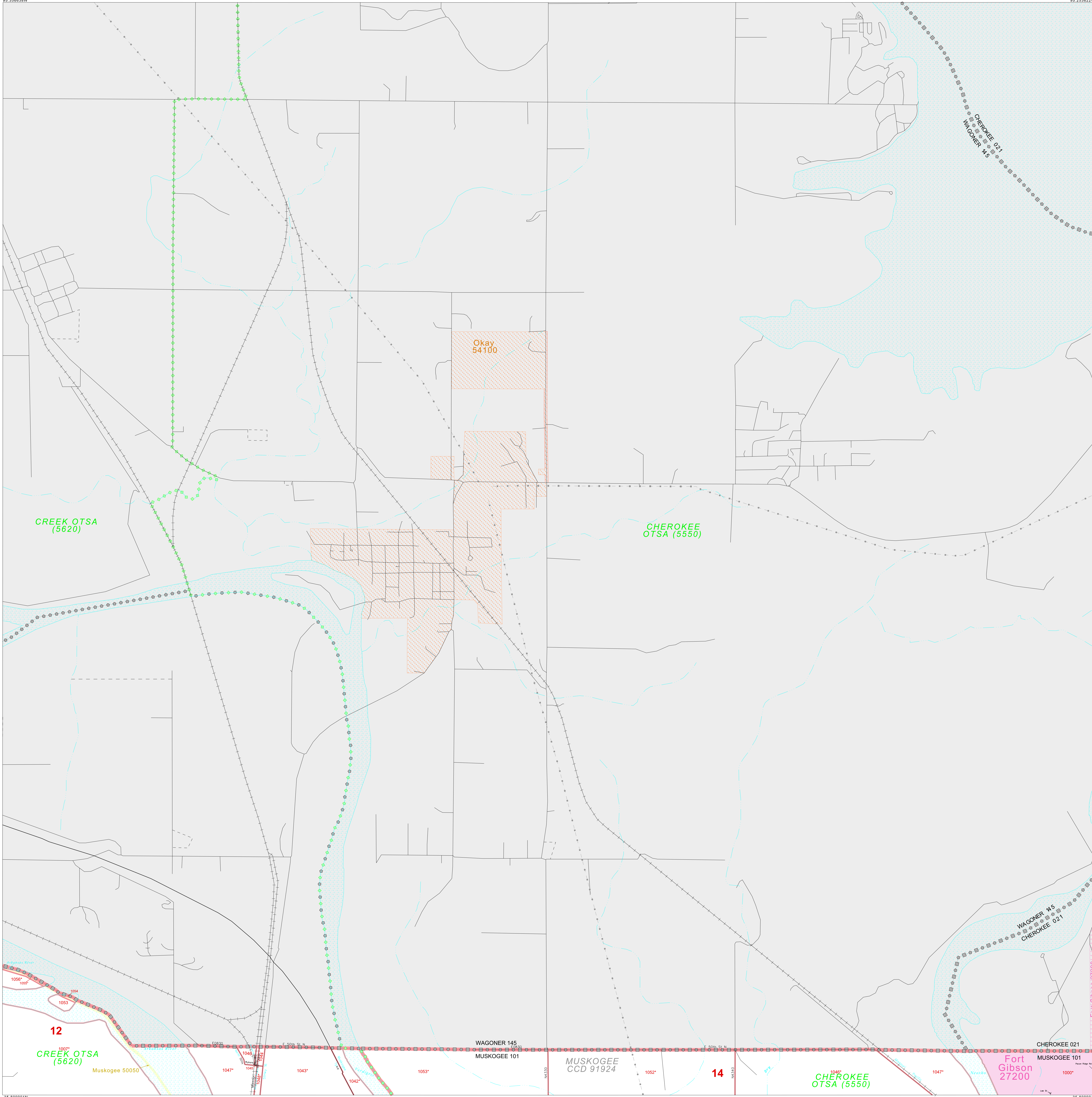


CENSUS 2000 BLOCK MAP: MUSKOGEE County

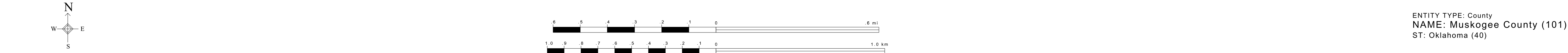
