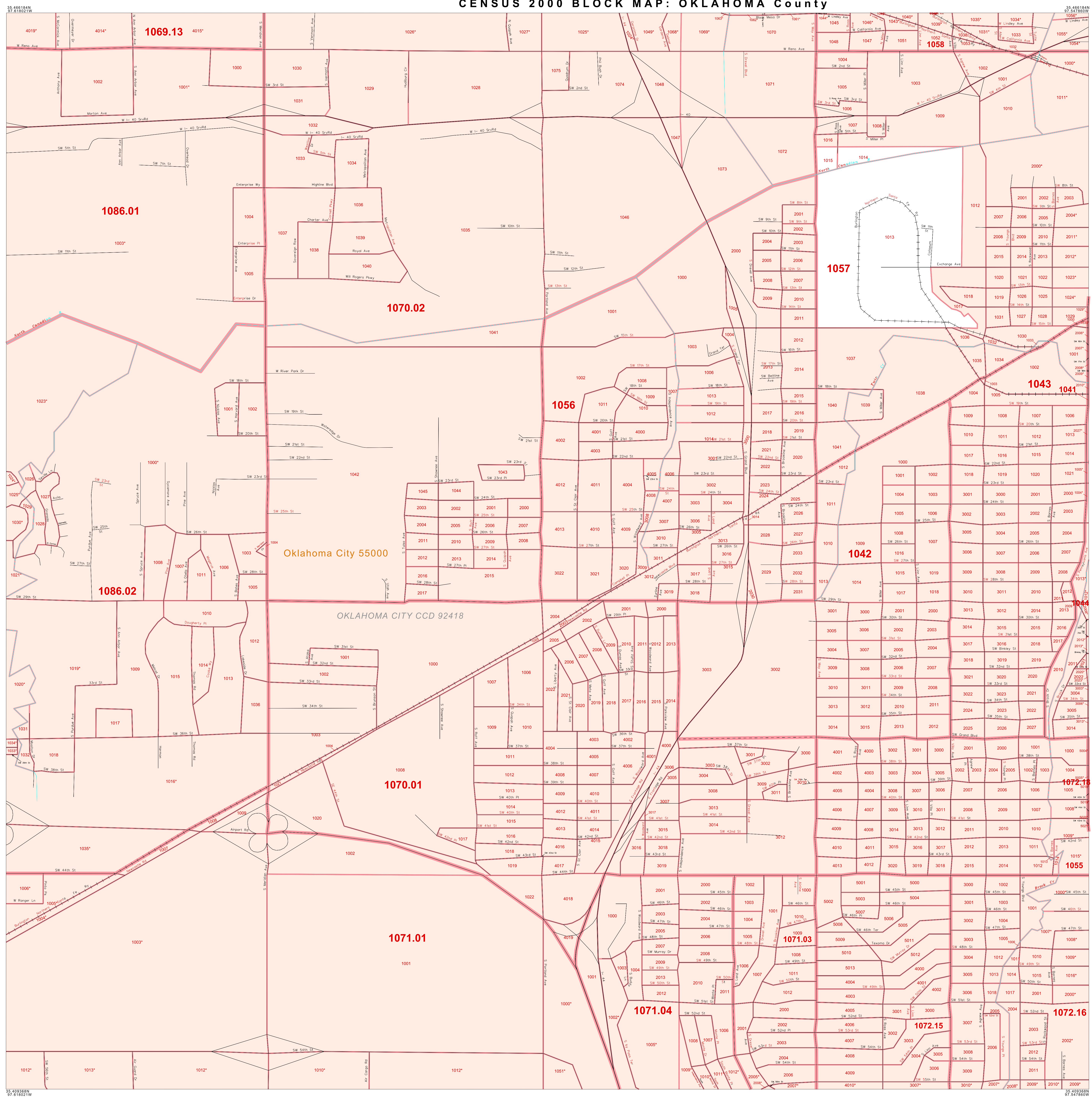


CENSUS 2000 BLOCK MAP: OKLAHOMA County
