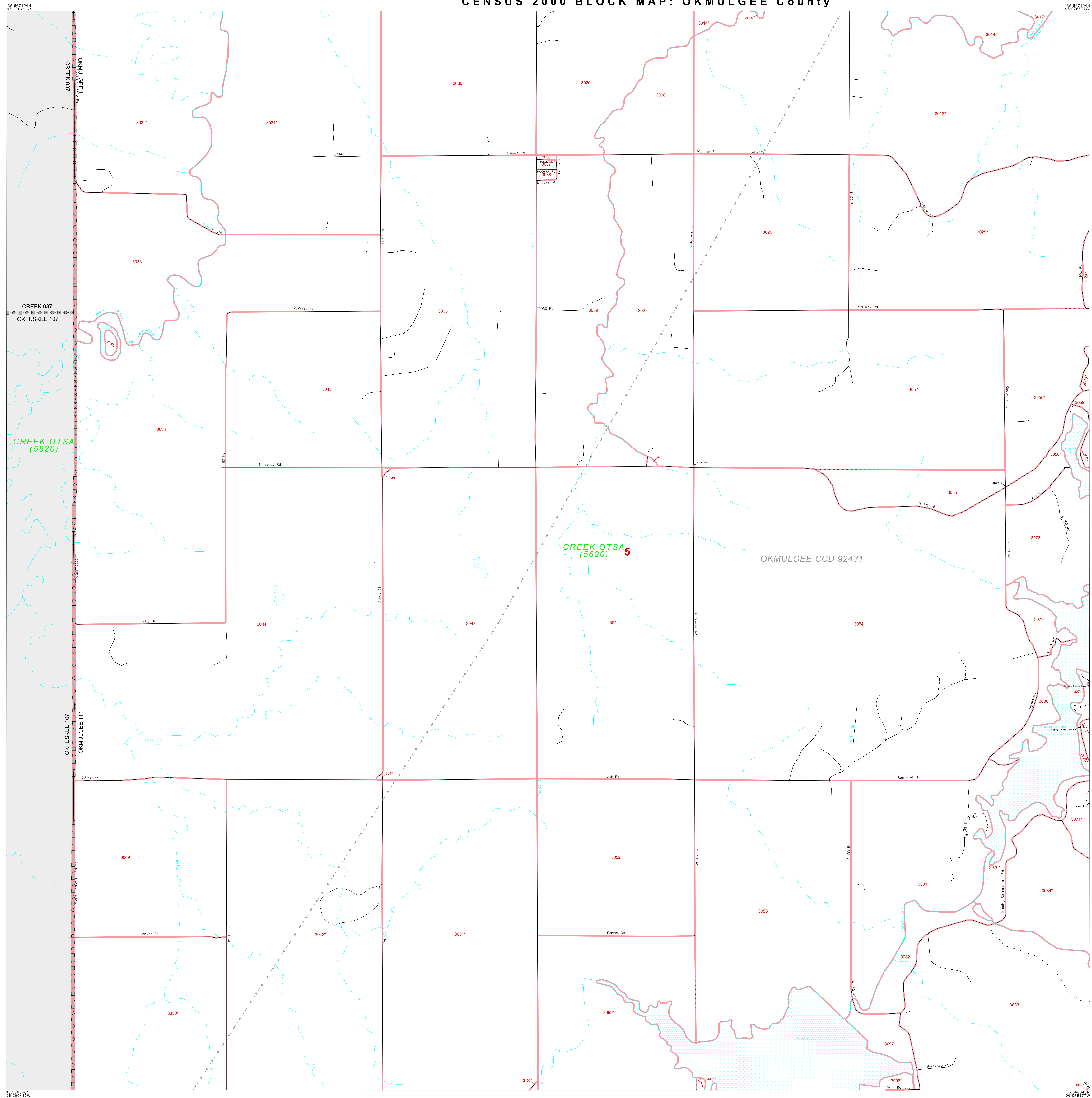


CENSUS 2000 BLOCK MAP: OKMULGEE County
