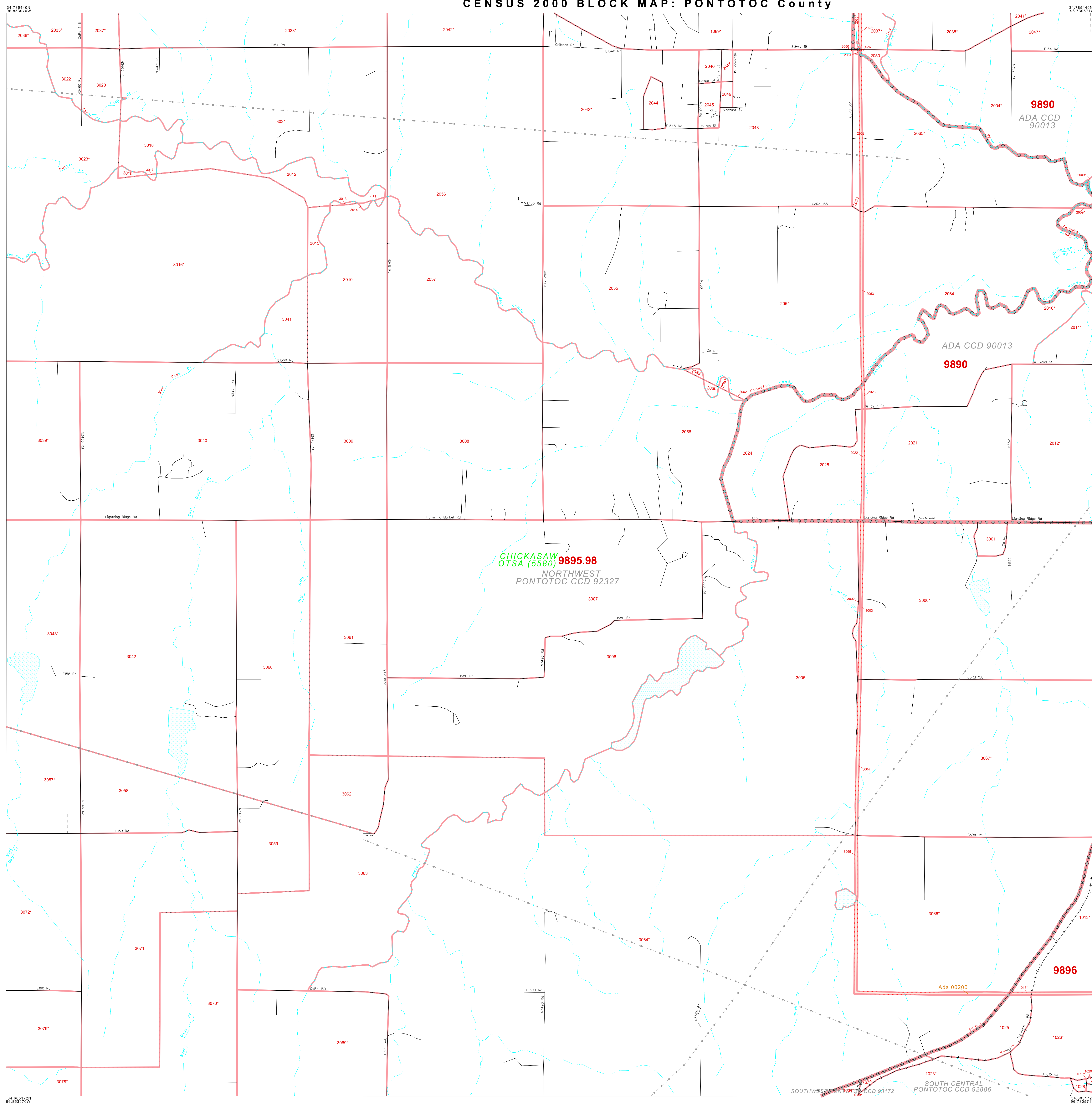


CENSUS 2000 BLOCK MAP: PONTOTOC County
