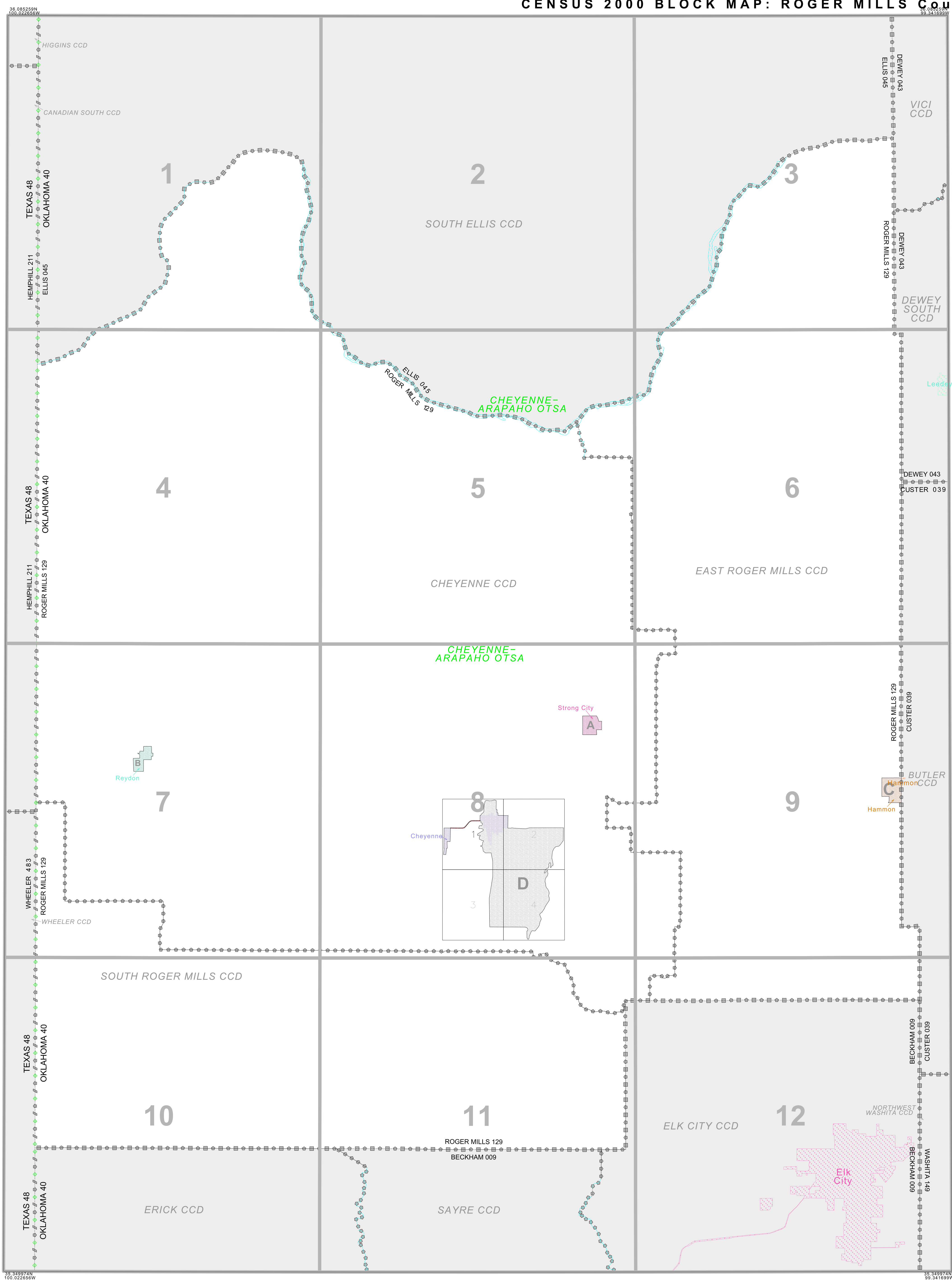


CENSUS 2000 BLOCK MAP: ROGER MILLS County
