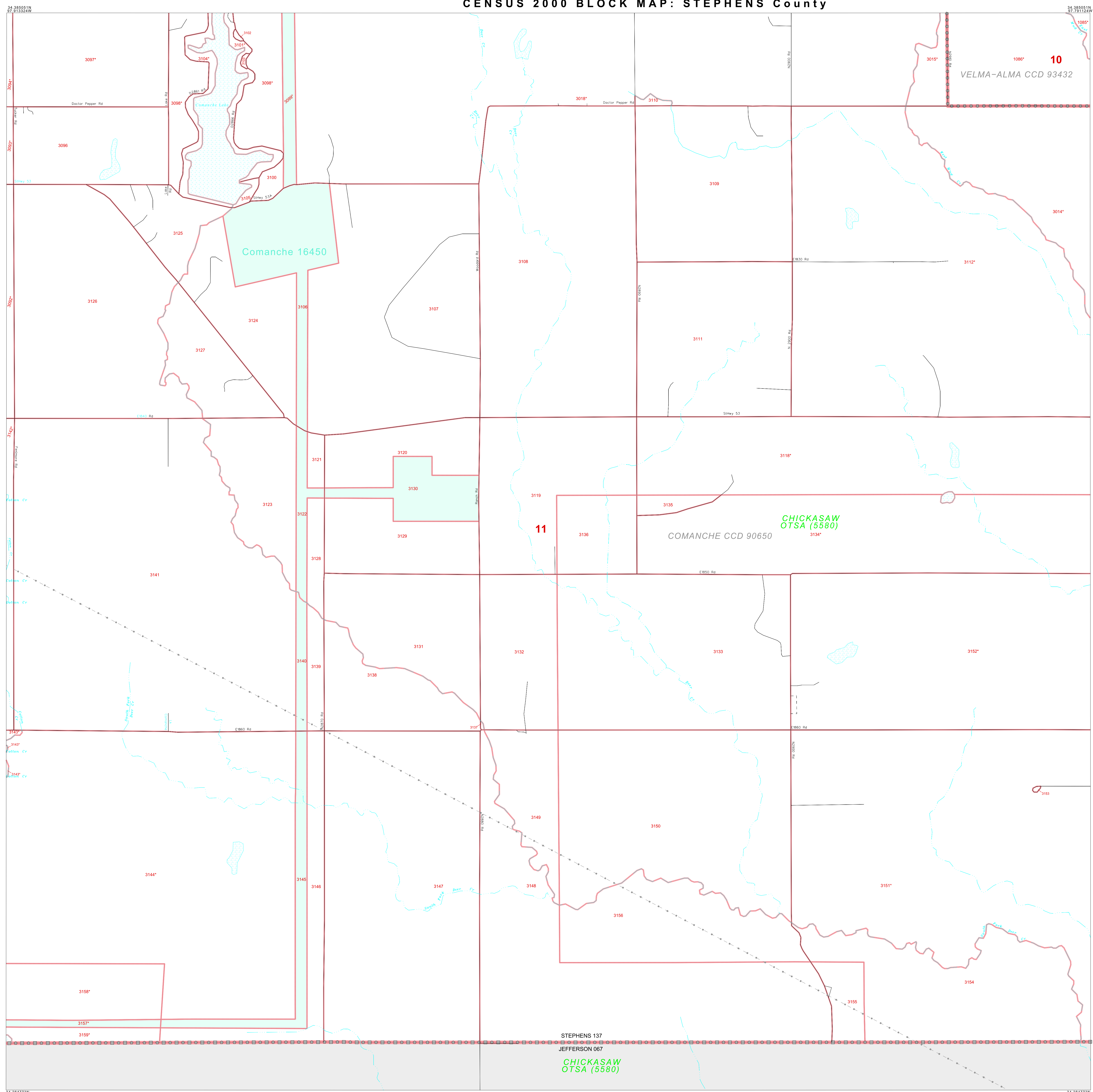


CENSUS 2000 BLOCK MAP: STEPHENS County
