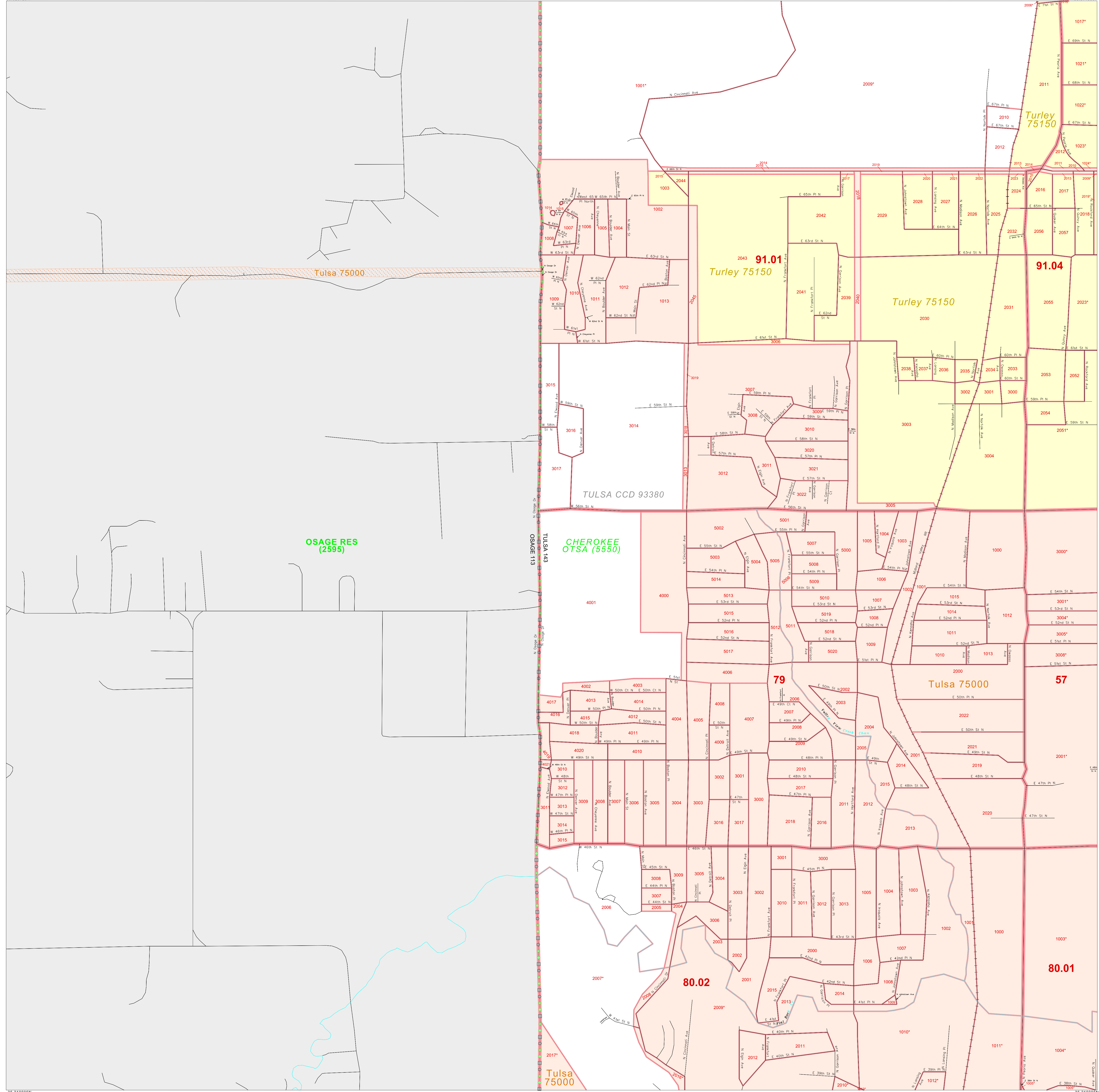


CENSUS 2000 BLOCK MAP: TULSA County

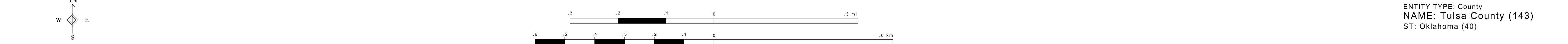
