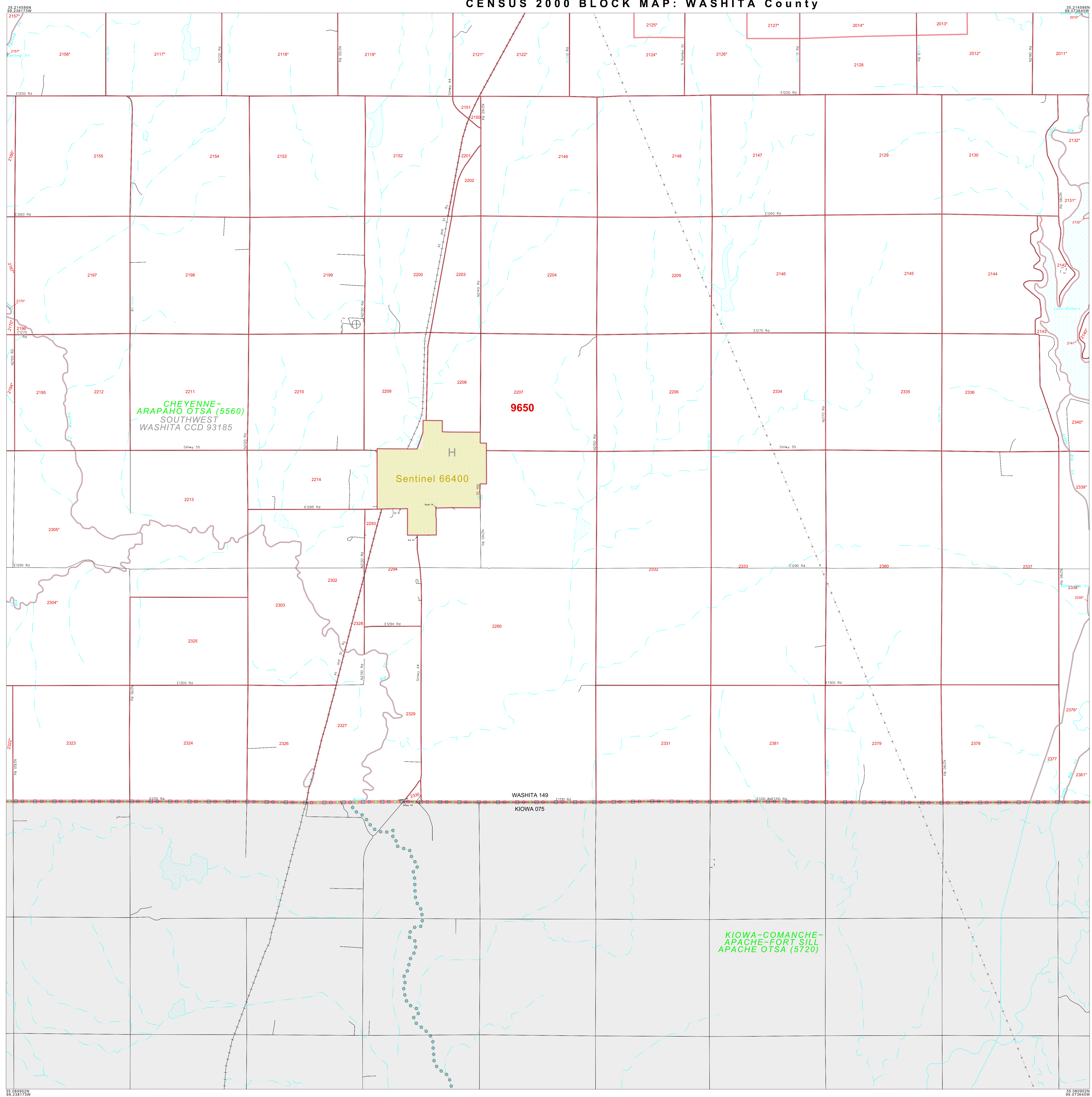


CENSUS 2000 BLOCK MAP: WASHITA County
