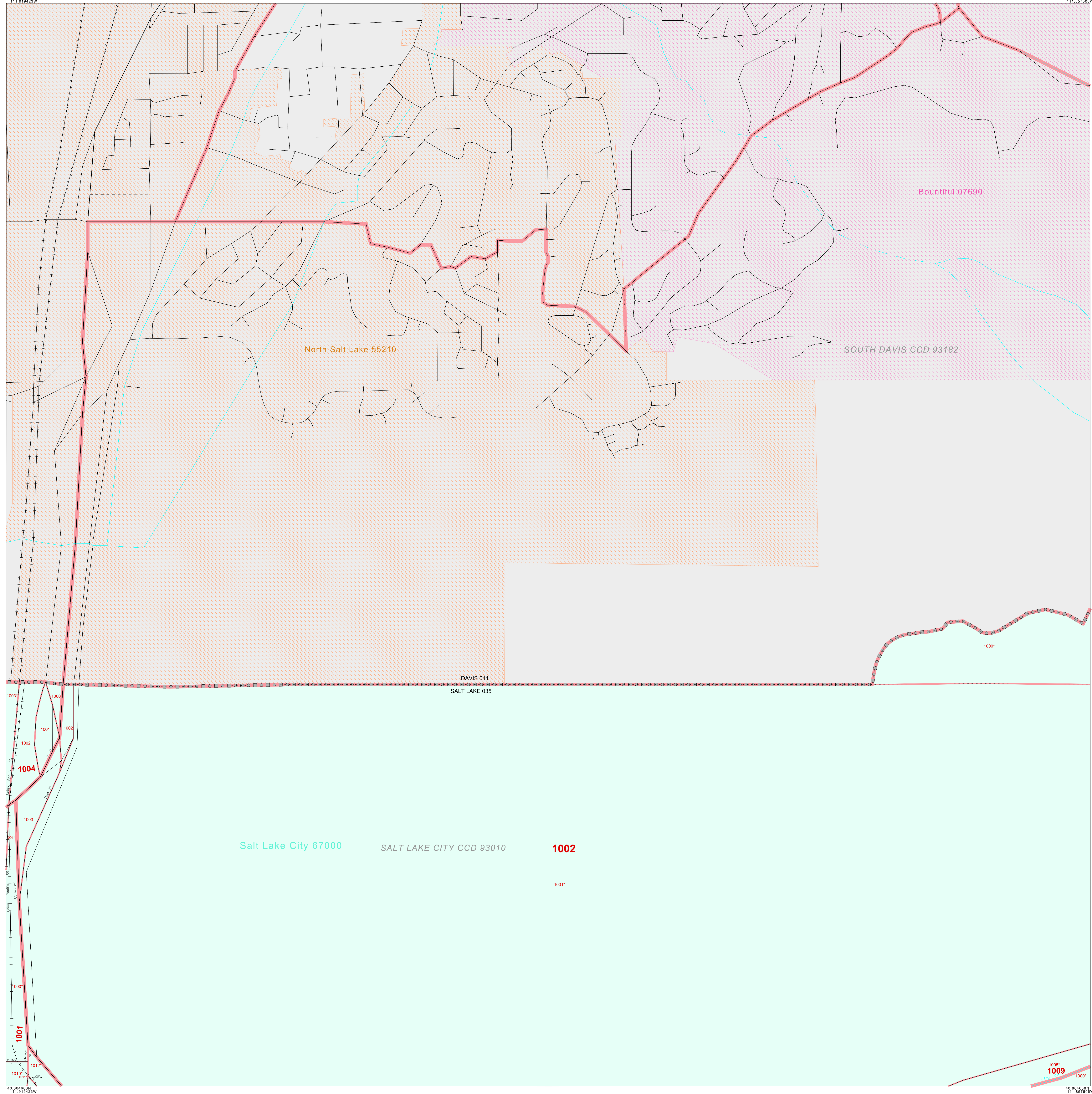


CENSUS 2000 BLOCK MAP: SALT LAKE CITY CCD

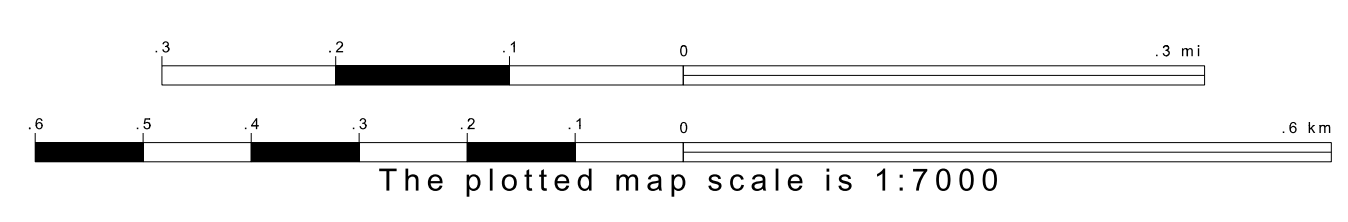
